CHAPTER _____

1 AN ACT concerning

2 **Tidal Fish Licenses – Oyster Authorizations – Administrative Penalties**

3 FOR the purpose of requiring the Department of Natural Resources to suspend for a certain
4 time ~~periods~~ period, rather than revoke, a person's oyster authorization for a first
5 offense of knowingly committing certain violations in the oyster fishery; requiring
6 ~~the Department to reinstate a person's revoked oyster authorization under certain~~
7 ~~circumstances~~ providing for the reinstatement for certain persons of an oyster
8 authorization and an entitlement to engage or work in the oyster fishery; altering a
9 certain offense related to the use of prohibited gear that serves as grounds for
10 suspension of an oyster authorization; repealing a certain time period within which
11 a certain administrative hearing must be held; and generally relating to
12 administrative penalties for oyster authorizations.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Natural Resources**

2 (a) (1) In addition to any other penalty or fine provided in this title, a person
3 who holds an authorization to catch oysters under § 4-701 of this title and receives a
4 citation for an offense listed under paragraph (2) of this subsection may, **IN ACCORDANCE**
5 **WITH THIS SECTION**, have the authorization [revoked in accordance with this section]:

6 (I) **FOR A FIRST VIOLATION, SUSPENDED FOR UP TO ~~2~~ 5 YEARS;**
7 **AND**

8 (II) **FOR A SECOND OR SUBSEQUENT VIOLATION, ~~SUSPENDED~~**
9 **~~FOR UP TO 10 YEARS~~ REVOKED.**

10 (2) The following offenses, committed in violation of this title or of any
11 regulation adopted under this title, are grounds for [revocation] **SUSPENSION OR**
12 **REVOCATION** of an authorization to catch oysters under this section:

13 (i) Taking oysters located more than 200 feet within a closed or
14 prohibited area;

15 (ii) Taking oysters with gear that is prohibited in that area **WHILE**
16 **MORE THAN 200 FEET WITHIN THE PROHIBITED AREA;**

17 (iii) Taking oysters outside of a time restriction for the harvest of
18 oysters by more than 1 hour;

19 (iv) Taking oysters during closed seasons; and

20 (v) Taking oysters from a leased area by a person other than the
21 leaseholder or the leaseholder's designee.

22 (b) (1) [(i)] Before the [revocation] **SUSPENSION OR REVOCATION** of an
23 authorization to catch oysters under this section, the Department shall hold a hearing on
24 the matter in accordance with the Administrative Procedure Act under Title 10, Subtitle 2
25 of the State Government Article.

26 [(ii)] A hearing held under subparagraph (i) of this paragraph shall be
27 held within 90 days after the cited individual commits the offense listed under subsection
28 (a)(2) of this section.]

29 (2) After a hearing is conducted under paragraph (1) of this subsection, if
30 the presiding officer finds or concludes that the person knowingly has committed an offense
31 listed under subsection (a)(2) of this section, the Department shall [revoke] **SUSPEND OR**
32 **REVOKE** the person's authorization to catch oysters **IN ACCORDANCE WITH SUBSECTION**
33 **(A)(1) OF THIS SECTION.**

1 (c) A person who is aggrieved by the final decision of the Department may obtain
2 judicial review of the decision in accordance with the Administrative Procedure Act under
3 Title 10, Subtitle 2 of the State Government Article.

4 (d) A person whose authorization has been [revoked] **SUSPENDED OR REVOKED**
5 in accordance with this section may not engage or work in the oyster fishery **WHILE**
6 **SUSPENDED OR REVOKED** whether or not [it] **THE WORK** requires the use of another
7 license.

8 (E) (1) ~~THIS SUBSECTION APPLIES TO A PERSON'S AUTHORIZATION TO~~
9 ~~CATCH OYSTERS THAT WAS REVOKED UNDER THIS SECTION BEFORE JULY 1, 2025.~~

10 (2) ~~THE DEPARTMENT SHALL REINSTATE A PERSON'S~~
11 ~~AUTHORIZATION TO CATCH OYSTERS IF:~~

12 (I) 1. ~~THE AUTHORIZATION HAS BEEN REVOKED FOR AT~~
13 ~~LEAST 2 YEARS; AND~~

14 2. ~~THE REVOCATION WAS THE PERSON'S FIRST OFFENSE~~
15 ~~ADJUDICATED AS A KNOWING VIOLATION UNDER THIS SECTION; OR~~

16 (H) 1. ~~THE AUTHORIZATION HAS BEEN REVOKED FOR AT~~
17 ~~LEAST 10 YEARS; AND~~

18 2. ~~THE REVOCATION WAS THE PERSON'S SECOND OR~~
19 ~~SUBSEQUENT OFFENSE ADJUDICATED AS A KNOWING VIOLATION UNDER THIS~~
20 ~~SECTION~~ THE DEPARTMENT MAY ACCEPT AN APPLICATION FOR AND ISSUE AN
21 OYSTER AUTHORIZATION TO A PERSON WHOSE OYSTER AUTHORIZATION WAS
22 REVOKED UNDER THIS SECTION BEFORE JULY 1, 2025, BEGINNING 5 YEARS AFTER
23 THE DATE OF REVOCATION.

24 (2) THE DEPARTMENT SHALL REINSTATE A PERSON'S ENTITLEMENT
25 TO ENGAGE OR WORK IN THE OYSTER FISHERY FOR A PERSON WHOSE
26 AUTHORIZATION TO CATCH OYSTERS WAS REVOKED UNDER THIS SECTION BEFORE
27 JULY 1, 2025, BEGINNING 5 YEARS AFTER THE DATE OF REVOCATION.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
29 1, 2025.
