2 Fisheries – Striped Bass or Rockfish – Juvenile Survey

- FOR the purpose of expanding the scope of the annual young-of-the-year juvenile survey of striped bass or rockfish by requiring the Department of Natural Resources to conduct the survey at sampling sites in the central region of the Maryland waters of the Chesapeake Bay in addition to sampling sites in the northern and southern regions of the Maryland waters of the Chesapeake Bay; establishing certain requirements for the central region sampling sites; and generally relating to striped bass or rockfish.

- 15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 16 That the Laws of Maryland read as follows:

17 Article – Natural Resources

- 19 **(A) (1)** The Department shall conduct annually a scientific survey to determine 20 the relative abundance of striped bass or rockfish of approximately 18 inches in length that 21 are in the Chesapeake Bay and its tributaries.
- 22 **(2)** The survey shall be conducted in areas that are used by the Department 23 to determine its young-of-the-year index of striped bass or rockfish.

1 (B) THE DEPARTMENT SHALL:

- 2 (1) CONDUCT THE ANNUAL YOUNG-OF-THE-YEAR JUVENILE SURVEY
- 3 OF STRIPED BASS OR ROCKFISH AT BETWEEN 12 AND 20, INCLUSIVE, SAMPLING
- 4 SITES LOCATED IN THE CENTRAL REGION OF THE MARYLAND WATERS OF THE
- 5 CHESAPEAKE BAY IN ADDITION TO SAMPLING SITES IN THE NORTHERN AND
- 6 SOUTHERN REGIONS OF THE CHESAPEAKE BAY; AND
- 7 (2) LOCATE THE CENTRAL REGION SAMPLING SITES IN ANY OF THE 8 FOLLOWING WATERS OF THE STATE:
- 9 (I) THE MAGOTHY RIVER;
- 10 (II) THE SEVERN RIVER;
- 11 (III) THE CHESTER RIVER;
- 12 (IV) THE SOUTH RIVER;
- 13 (V) THE WEST RIVER;
- 14 (VI) EASTERN BAY; OR
- 15 (VII) THE MILES RIVER.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2025.
