16	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 1 (b) (1) A speed monitoring system may not be used in a local jurisdiction (i) 2 under this section unless its use is authorized by the governing body of the local jurisdiction 3 by local law enacted after reasonable notice and a public hearing. 4 (vi) This section applies to a violation of this subtitle recorded by a 5 speed monitoring system that meets the requirements of this subsection and has been 6 placed: 7 In Anne Arundel County, Montgomery County, or Prince 1. 8 George's County, on a highway in a residential district, as defined in § 21–101 of this title, 9 with a maximum posted speed limit of 35 miles per hour, which speed limit was established using generally accepted traffic engineering practices; 10 2. 11 In a school zone with a posted speed limit of at least 20 miles per hour; 12 13 3. - 1 (I) IF THE CITATION ALLEGES THAT THE DRIVER OF THE 2 MOTOR VEHICLE EXCEEDED THE SPEED LIMIT BY BETWEEN 12 AND 15, INCLUSIVE, 3 MILES PER HOUR, \$40;
- 4 (II) IF THE CITATION ALLEGES THAT THE DRIVER OF THE 5 MOTOR VEHICLE EXCEEDED THE SPEED LIMIT BY BETWEEN 16 AND 19, INCLUSIVE, 6 MILES PER HOUR, \$55;
- 7 (III) IF THE CITATION ALLEGES THAT THE DRIVER OF THE 8 MOTOR VEHICLE EXCEEDED THE SPEED LIMIT BY BETWEEN 20 AND 29, INCLUSIVE, 9 MILES PER HOUR, \$95;
- 10 (IV) IF THE CITATION ALLEGES THAT THE DRIVER OF THE
 11 MOTOR VEHICLE EXCEEDED THE SPEED LIMIT BY BETWEEN 30 AND 39, INCLUSIVE,
 12 MILES PER HOUR, \$180; AND
- 13 (V) IF THE CITATION ALLEGES THAT THE DRIVER OF THE MOTOR VEHICLE EXCEEDED THE SPEED LIMIT BY 40 MILES PER HOUR OR MORE, 15 \$350.
- 16 (3) For purposes of this section, the District Court shall prescribe[:
- 17 (i) A] A uniform citation form consistent with subsection (d)(1) of 18 this section and § 7–302 of the Courts Article[; and
- 19 (ii) A civil penalty, which shall be indicated on the citation, to be paid 20 by persons who choose to prepay the civil penalty without appearing in District Court].
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2025.
