## A BILL ENTITLED

### 1 AN ACT concerning

# State Department of Assessments and Taxation and Department of General Services - Property Appraisal Aids - Geographic Images

FOR the purpose of requiring the State Department of Assessments and Taxation to
prepare, install, and maintain certain property appraisal aids that consist of a
database of certain geographic images; requiring the Department of General
Services to procure for the State a certain uniform system that includes any tools or
services needed to prepare, maintain, and install the appraisal aids; requiring each
county and Baltimore City to reimburse the State for certain costs of the database of
geographic images; and generally relating to property appraisal aids and records.

- SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
   That the Laws of Maryland read as follows:
