## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Real Property – Recordation and Land Records – Requirements**

3 FOR the purpose of altering certain provisions relating to the filing, maintenance, and  
4 transmittal of land records; and generally relating to the recordation of instruments  
5 affecting real property and land records.

6 BY repealing and reenacting, with amendments,

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

18 That the Laws of Maryland read as follows:

19 **Article – Real Property**

2 (a) In this article the following words have the meanings indicated unless  
3 otherwise apparent from context.

4 (b) "County" includes Baltimore City.

5 (c) "Deed" includes any deed, grant, mortgage, deed of trust, lease, assignment,  
6 and release, pertaining to land or property or any interest therein or appurtenant thereto,  
7 including an interest in rents and profits from rents.

8 (d) (1) "Deed of trust" means [only] a deed of trust [which] **THAT** secures a  
9 debt or the performance of an obligation[, and].

10 (2) "**DEED OF TRUST**" does not include a voluntary grant unrelated to  
11 security purposes.

12 (e) "Grant" includes conveyance, assignment, and transfer.

13 (f) "Land" [has the same meaning as "property"] **MEANS PROPERTY.**

14 (g) "**LAND RECORD**" **MEANS ANY DOCUMENT RECORDED BY A CLERK OF**  
15 **THE CIRCUIT COURT AFFECTING THE TITLE TO PROPERTY.**

16 [(g)] (h) "Landlord" means any landlord, including a ["lessor"] **LESSOR.**

17 [(h)] (i) "Lease" means any oral or written agreement, express or implied,  
18 creating a landlord and tenant relationship, including any ["sublease"] **SUBLEASE** and any  
19 further sublease.

20 [(i)] (j) "Mortgage" means any mortgage, including a deed in the nature of  
21 mortgage.

22 [(j)] (k) "Person" includes an individual, A receiver, A trustee, A guardian, AN  
23 executor, AN administrator, A fiduciary, or A representative of any kind, or any partnership,  
24 firm, association, public or private corporation, or any other entity.

25 [(k)] (l) "Property" means real property or any interest [therein or appurtenant  
26 thereto] **IN REAL PROPERTY.**

27 [(l)] (m) "Purchaser" [has the same meaning as] **MEANS A** buyer or vendee.

28 [(m)] (n) "Tenant" means any tenant including a ["lessee"] **LESSEE.**

29 [(n)] (o) "Vendor" [has the same meaning as] **MEANS A** seller.

1 3-104.

2 (a) (1) The [Clerk of the Circuit Court] **CLERK OF THE CIRCUIT COURT** may  
3 record an instrument that effects a change of ownership if the instrument is:

4 (i) Endorsed with the certificate of the collector of taxes of the  
5 county in which the property is assessed, required under subsection (b) of this section;

6 (ii) 1. Accompanied by a complete intake sheet; or

7 2. Endorsed by the assessment office for the county as  
8 provided in subsection (g)(8) of this section; and

9 (iii) Accompanied by a copy of the instrument, and any survey, for  
10 submission to the Department of Assessments and Taxation.

11 (2) The Supervisor of Assessments shall transfer ownership of property in  
12 the assessment records, effective as of the date of recordation, [upon] **ON** receipt from the  
13 [Clerk of the Circuit Court] **CLERK OF THE CIRCUIT COURT** of a copy of the instrument,  
14 the completed intake sheet, and any survey submitted under paragraph (1) of this  
15 subsection **OR DOCUMENTS RECEIVED THROUGH AN ELECTRONIC RECORDATION**  
16 **SYSTEM.**

17 (d) (1) Every deed or other instrument offered for recordation shall have the  
18 name of each person typed or printed directly above or below the signature of the person.

19 (2) If a typed or printed name is not provided as required in this subsection,  
20 the clerk shall make reasonable efforts to determine the correct name under which the deed  
21 or other instrument shall be indexed.

22 (e) (1) (I) Any printed deed or other instrument offered for recordation  
23 shall [be]:

24 1. **BE** printed in not less than [eight-point] ~~10 8~~ **POINT** type  
25 and in black letters and be on white paper of sufficient weight and thickness to be clearly  
26 readable. If the deed or other instrument is wholly typewritten or typewritten on a printed  
27 form, the typewriting shall be in black letters, in not less than elite type and [upon] **ON**  
28 white paper of sufficient weight or thickness as to be clearly readable. The foregoing  
29 provisions do not apply to manuscript covers or backs customarily used on documents  
30 offered for recordation. The recording charge for any instrument not conforming to these  
31 requirements shall be [treble] **THREE TIMES** the normal [charge] **AMOUNT CHARGED.** In  
32 any clerk's office where the deeds or other instruments are [photostated or microfilmed]  
33 **SCANNED**, no instrument on which a rider has been placed or attached in a manner  
34 obscuring, hiding, or covering any other part of the instrument may be offered or received  
35 for record. No instrument not otherwise readily subject to [photostating or microfilming]  
36 **SCANNING** may be offered or received for record until [treble] **THREE TIMES** the normal

1 recording charge is paid to the clerk and unless an affidavit, black type on white paper, is  
 2 attached and made a part of the document stating the kind of instrument, the date, the  
 3 parties to the transaction, description of the property, and all other pertinent data; AND

4 **2. INCLUDE AT LEAST A 3-INCH MARGIN AT THE TOP OF**  
 5 **THE FIRST PAGE AND 1-INCH MARGINS ON ALL REMAINING SIDES OF EACH PAGE OF**  
 6 **THE INSTRUMENT FOR OFFICIAL USE.**

7 ~~(II) A CLERK MAY REFUSE TO RECORD AN INSTRUMENT THAT~~

12 (III) After any document has been recorded in one county, a certified  
 13 copy of the recorded document may be recorded in any other county.

15 (a) A mortgage or deed of trust may be released validly by any procedure  
 16 enumerated in this section or § 3-105.2 of this subtitle.

17 (b) (1) A release may be endorsed on the original mortgage or deed of trust by  
 18 the mortgagee or [his] AN assignee OF THE MORTGAGEE, the trustee or [his] A successor  
 19 OF THE TRUSTEE under a deed of trust, or by the holder of the debt or obligation secured  
 20 by the deed of trust.

21 (2) The mortgage or the deed of trust, with the endorsed release, then shall  
 22 be filed in the office in which the mortgage or deed of trust is recorded.

23 (3) The clerk shall record the release [photographically], with an  
 24 attachment or rider affixed to it containing the names of the parties as they appear on the  
 25 original mortgage or deed of trust, together with a reference to the book and page number  
 26 where the mortgage or deed of trust is recorded.

27 [(c) At the option of the clerk of the court in whose office the book form of recording  
 28 is used, the release may be written by the mortgagee, or his assignee, or the trustee, or his  
 29 successor under a deed of trust, on the record in the office where the mortgage or deed of  
 30 trust is recorded and attested by the clerk of the court. At the time of recording any  
 31 mortgage or deed of trust, the clerk of the court in whose office the book form of recording  
 32 is used shall leave a blank space at the foot of the mortgage or deed of trust for the purpose  
 33 of entering such release.]

34 [(d)] (C) (1) (I) When the debt secured by a deed of trust is paid fully or  
 35 satisfied, and any bond, note, or other evidence of the total indebtedness is marked "paid"

1 or “canceled” by the holder or [his] **AN agent OF THE HOLDER**, it may be received by the  
2 clerk and indexed and recorded as any other instrument in the nature of a release.

3           **(II)** The marked note has the same effect as a release of the property  
4 for which it is the security, as if a release were executed by the named trustees, if there is  
5 attached to or endorsed on the note an affidavit of the holder, the party making satisfaction,  
6 or an agent of either of them, that it has been paid or satisfied, and specifically setting forth  
7 the land record reference where the original deed of trust is recorded.

8           (2) **(I)** When the debt secured by a mortgage is paid fully or satisfied,  
9 and the original mortgage is marked “paid” or “canceled” by the mortgagee or [his] **AN**  
10 **agent OF THE MORTGAGEE**, it may be received by the clerk and indexed and recorded as  
11 any other instrument in the nature of a release.

12           **(II)** The marked mortgage has the same effect as a release of the  
13 property for which it is the security, as if a release were executed by the mortgagee, if there  
14 is attached to or endorsed on the mortgage an affidavit of the mortgagee, the mortgagor,  
15 the party making satisfaction, or the agent of [any of them] **THE MORTGAGEE, THE**  
16 **MORTGAGOR, OR THE PARTY MAKING SATISFACTION**, that it has been paid or satisfied,  
17 and specifically setting forth the land record reference where the mortgage is recorded.

18           (3) **(I)** When the debt secured by a mortgage or deed of trust is paid fully  
19 or satisfied, and the canceled check evidencing final payment or, if the canceled check is  
20 unavailable, a copy of the canceled check accompanied by a certificate from the institution  
21 on which the check was drawn stating that the copy is a true and genuine image of the  
22 original check is presented, it may be received by the clerk and indexed and recorded as  
23 any other instrument in the nature of a release.

24           **(II)** The canceled check or copy accompanied by the certificate has  
25 the same effect as a release of the property for which the mortgage or deed of trust is the  
26 security, as if a release were executed by the mortgagee or named trustees, if:

27           **[(i)] 1.** The party making satisfaction of the mortgage or deed of  
28 trust has:

29                   **[1.] A.** Allowed at least a 60–day waiting period, from the  
30 date the mortgage or deed of trust is paid fully or is satisfied, for the party satisfied to  
31 provide a release suitable for recording;

32                   **[2.] B.** Sent the party satisfied a copy of this section and a  
33 notice that, unless a release is provided within 30 days, the party making satisfaction will  
34 obtain a release by utilizing the provisions of this paragraph; and

35                   **[3.] C.** Following the mailing of the notice required under  
36 item 2 of this item, allowed an additional waiting period of at least 30 days for the party  
37 satisfied to provide a release suitable for recording; [and]

1            [(ii)] **2.**     The canceled check or copy accompanied by the certificate  
2 contains the name of the party whose debt is being satisfied, the debt account number, if  
3 any, and words indicating that the check is intended as payment in full of the debt being  
4 satisfied; and

5            [(iii)] **3.**     There is attached to the canceled check or copy  
6 accompanied by the certificate an affidavit made by a member of the Maryland Bar that  
7 the mortgage or deed of trust has been satisfied, that the notice required under item [(i)] **1**  
8 of this [paragraph] **SUBPARAGRAPH** has been sent, and specifically setting forth the land  
9 record reference where the original mortgage or deed of trust is recorded.

10            (4)    **(I)**     When the debt secured by a mortgage or deed of trust is fully paid  
11 or satisfied and the holder or the agent of the holder of the mortgage or deed of trust note  
12 or other obligation secured by the deed of trust, or the trustee or successor trustee under  
13 the deed of trust, executes and acknowledges a certificate of satisfaction substantially in  
14 the form specified under § 4–203(d) of this article, containing the name of the debtor, holder,  
15 the authorized agent of the holder, or the trustee or successor trustee under the deed of  
16 trust, the date, and the land record recording reference of the instrument to be released, it  
17 may be received by the clerk and indexed and recorded as any other instrument in the  
18 nature of a release.

19            **(II)**     The certificate of satisfaction shall have the same effect as a  
20 release executed by the holder of a mortgage or the named trustee under a deed of trust.

21            (5)    **(I)**     When the holder of a mortgage or deed of trust note or other  
22 obligation secured by the deed of trust has agreed to release certain property from the lien  
23 of the mortgage or deed of trust and the holder or the agent of the holder of the mortgage  
24 or deed of trust note or other obligation secured by the deed of trust, or the trustee or  
25 successor trustee under the deed of trust executes and acknowledges a certificate of partial  
26 satisfaction or partial release substantially in the form specified under § 4–203(e) of this  
27 article, containing the name of the debtor, holder, the authorized agent of the holder, or the  
28 trustee or successor trustee under the deed of trust, the date, the land record recording  
29 reference of the instrument to be partially released, and a description of the real property  
30 being released, it may be received by the clerk and indexed and recorded as any other  
31 instrument in the nature of a partial release.

32            **(II)**     The certificate of partial satisfaction or partial release shall have  
33 the same effect as a partial release executed by the holder of a mortgage, the holder of the  
34 debt secured by a deed of trust, or the named trustee under a deed of trust.

35            [(e)] **(D)**     A release of a mortgage or deed of trust may be made on a separate  
36 instrument if it states that the mortgagee, holder of the debt or obligation secured by the  
37 deed of trust, trustee, or assignee releases the mortgage or deed of trust and states the  
38 names of the parties to the mortgage or deed of trust and the date and recording reference

1 of the mortgage or deed of trust to be released. In addition, any form of release that satisfies  
2 the requirements of a deed and is recorded as required by this article is sufficient.

3 **[(f)] (E)** (1) A holder of a debt secured by a mortgage or deed of trust, or a  
4 successor of a holder, may release part of the collateral securing the mortgage or deed of  
5 trust by executing and acknowledging a partial release on an instrument separate from the  
6 mortgage or deed of trust.

7 (2) A partial release shall:

8 (i) Be executed and acknowledged;

9 (ii) Contain the names of the parties to the mortgage or deed of trust,  
10 the date, and the land record recording reference of the instrument subject to the partial  
11 release; and

12 (iii) Otherwise satisfy the requirements of a valid deed.

13 (3) The clerk of the court shall accept, index, and record, as a partial  
14 release, an instrument that complies with and is filed under this section.

15 (4) Unless otherwise stated in an instrument recorded among the land  
16 records, a trustee under a deed of trust may execute, acknowledge, and deliver partial  
17 releases.

18 **[(g)] (F)** If a full or partial release of a mortgage or deed of trust is recorded  
19 [other than at the foot of the recorded mortgage or deed of trust], the clerk shall place a  
20 reference to the book and page number or other place where the release is recorded on the  
21 recorded mortgage or deed of trust.

22 **[(h)] (G)** Unless otherwise expressly provided in the release, a full or partial  
23 release that is recorded for a mortgage or deed of trust that is re-recorded, amended,  
24 modified, or otherwise altered or affected by a supplemental instrument and which cites  
25 the released mortgage or deed of trust by reference to only the original recorded mortgage,  
26 deed of trust, or supplemental instrument to the original mortgage or deed of trust, shall  
27 be effective as a full or partial release of the original mortgage or deed of trust and all  
28 supplemental instruments to the original mortgage or deed of trust.

29 **[(i)] (H)** Unless otherwise expressly provided in the release, a full or partial  
30 release that is recorded for a mortgage or deed of trust, or for any re-recording, amendment,  
31 modification, or supplemental instrument to the mortgage or deed of trust shall terminate  
32 or partially release any related financing statements, but only to the extent that the  
33 financing statements describe fixtures that are part of the collateral described in the full  
34 or partial release.

1 The clerk of the **CIRCUIT** court shall record [photographically] any assignment of a  
2 mortgage with an attachment or rider affixed to it containing the names of the parties as  
3 they appear on the original mortgage and a reference to the book number and page number  
4 where the mortgage is recorded.

5 3–108.

6 (a) (1) Except as provided in paragraph (2) of this subsection, the provisions of  
7 this section are in addition to any other provisions of the Code, pertaining to recordation of  
8 subdivision plats.

9 (2) [The provisions of this] **THIS** section [do] **DOES** not apply in Queen  
10 Anne’s County.

11 (b) (1) If the owner of land in the State subdivides [his] **THE** land for  
12 commercial, industrial, or residential use to be comprised of streets, avenues, lanes, or  
13 alleys and lots, and desires, for the purpose of description and identification, to record a  
14 plat of the subdivision among the land records of the county where the land lies, the clerk  
15 of the court shall accept and record the plat as prescribed in this section.

16 (2) The clerk may not accept the plat for record until the owner of land  
17 complies with the requirements prescribed in this section.

18 (c) (1) In this subsection, “coordinate” means a number which determines the  
19 position of any point in a north or south and an east or west direction in relation to any  
20 other point in the same coordinate system.

21 (2) The plat shall be legible, drawn accurately and to scale and shall be  
22 submitted for recordation using black ink on transparent mylar[, or linen] or black–line  
23 photo process comparable to original quality that will conform to archival standards. [The  
24 State Highway Administration may substitute microfilm aperture cards showing property  
25 or rights–of–way to be acquired or granted. Microfilm aperture cards must meet archival  
26 standards for permanent records.]

27 (3) The plat shall contain the courses and distances of all lines drawn on  
28 the plat.

29 (4) With respect to all curved lines, the plat shall show the length of all  
30 radii, arcs, and tangents and the courses and distances of all chords.

31 (5) The plat shall contain a north arrow which represents and designates  
32 either true or magnetic meridian as of a date specified on the plat or shall be referenced to  
33 a recognized coordinate system within the county.

34 (6) All courses shown on the plat shall be calculated from the plat meridian.



1 (7) No distance on the plat may be marked “more or less” except on lines  
2 which begin, terminate, or bind on a marsh, stream, or any body of water.

3 (8) (I) The plat shall show the position by coordinates of not less than  
4 four markers set in convenient places within the subdivision in a manner so that the  
5 position of one marker is visible from the position of one other marker.

6 (II) From these markers, commonly called [“traverse points”]  
7 **TRAVERSE POINTS**, every corner and line can be readily calculated and marked on the  
8 ground.

9 (III) These markers shall comply with standards that the State Board  
10 for Professional Land Surveyors sets by regulation under § 15–208 of the Business  
11 Occupations and Professions Article.

12 (9) A certificate stating that the requirement of this subsection, as far as it  
13 concerns the making of the plat and setting of the markers, shall be put on the plat and  
14 signed by the owner of the land shown on the plat to the best of [his] **THE OWNER’S**  
15 knowledge and by the professional land surveyor or property line surveyor preparing it.

16 (d) (1) [Three linen] **THE OWNER SHALL MAIL OR DELIVER THREE** copies  
17 of the plat [shall be mailed or delivered] to the clerk.

18 (2) (I) [The] **EXCEPT AS PROVIDED IN SUBPARAGRAPH (II) OF THIS**  
19 **PARAGRAPH, THE** fee is \$5 for each set of plats[, except that a].

20 (II) A fee is not required for plats [or microfilm aperture cards]  
21 showing property or rights-of-way to be acquired or granted by the State Highway  
22 Administration.

23 (III) **THE CLERK MAY ASSESS ADDITIONAL FEES IF REQUIRED BY**  
24 **LOCAL LAW OR ORDINANCE.**

25 (e) Each plat shall be signed and sealed by a professional land surveyor or  
26 property line surveyor licensed in the State.

27 3–301.

28 (a) (1) If the person offering a deed or other instrument affecting property for  
29 record first pays the recording fees, the clerk of the circuit court of each county shall record  
30 every deed and other instrument affecting property in [well-bound books to be named  
31 “Land Records”, if that is the practice in the county, or on microfilm, if that is the practice]  
32 **LAND RECORDS AVAILABLE TO THE PUBLIC.**

1           **(2)** The clerk shall endorse on the deed or other instrument the time [he  
2 receives] **OF RECEIPT OF** the document for recording and the endorsement shall show in  
3 the [Land Records] **LAND RECORDS**.

4           **(3)** Any deed or other instrument affecting property which also affects  
5 personal property shall be recorded in the same manner in the [Land Records] **LAND**  
6 **RECORDS** only, and not in the ["Financing Records"] **FINANCING STATEMENTS**.

7           (b) If an interested party so requests, the ["Financing Records"] **FINANCING**  
8 **STATEMENTS** provided for in § 9-402(9) of the Commercial Law Article shall include a  
9 notation that the instrument is recorded among the ["Land Records"] **LAND RECORDS**.  
10 The instrument also shall be indexed in the general alphabetical index provided in § 3-302  
11 of this subtitle. The notation and indexing have the same effect as if the instrument were  
12 recorded in full among the ["Financing Records"] **FINANCING STATEMENTS**.

13           (c) **(1)** The clerk may not refuse to accept any deed or other document entitled  
14 to be recorded, solely on the grounds that the deed or document contains a  
15 strike-through, interlineation, or other corrections.

16           **(2)** The clerk may refuse to accept for re-recording, a previously recorded  
17 deed or document that has been corrected or altered by a strike-through, interlineation, or  
18 similar corrective measures, and that has not been re-executed, [initialled] **INITIALED**, or  
19 otherwise ratified in writing by the party or parties affected by the correction.

20 3-302.

21           (a) **(1)** The clerk of the circuit court of each county shall make and maintain a  
22 full and complete general alphabetical index of every deed, and other instrument [in a  
23 well-bound book in his office].

24           **(2)** The index shall [be]:

25           **(I)** **BE** both in the name of each grantor, donor, mortgagor, and  
26 assignor, and each grantee, donee, mortgagee, or assignee[. It shall include]; **AND**

27           **(II)** **INCLUDE** the book and page of the recordation of every  
28 instrument designating these names.

29           **(3)** The clerk shall index every deed or other instrument ~~retaining~~ a  
30 vendor's lien both as a deed and as a vendor's lien,~~]~~ in the same manner as mortgages are  
31 indexed.

32           (b) [In every clerk's office where land records are not recorded in book form, the]  
33 **THE** clerk shall index every assignment of a mortgage, deed of trust, and release or partial  
34 [releases] **RELEASE** of a deed of trust, whether in long or short form[, in the general

1 alphabetical index, and shall place an entry in the general alphabetical index where the  
2 instrument is indexed, on the same horizontal line, indicating the place of record of the  
3 original instrument being assigned or released].

4 [(c) The clerk of the circuit court of each county shall date each change or  
5 correction made to information in the general alphabetical index on the horizontal line on  
6 which the change or correction was made.]

7 [(d) (C) (1) If a court [of equity] decrees a payment of cost or makes some  
8 other decree for payment of money by a plaintiff, the clerk immediately shall [enter] **INDEX**  
9 the plaintiff's name [in a separate index, known as the index of plaintiffs].

10 (2) Until the plaintiff's name is indexed, no lien under the decree arises  
11 against the property of the plaintiff and no right of execution accrues on the decree.

12 [(e) (D) (1) The clerk shall ~~[include in the]~~ index each property identifier  
13 provided on an intake sheet under § 3-104(g) of this title ~~[or, if the space available in the~~  
14 index will not accommodate all of the identifiers, then as many as the space allows, giving  
15 priority to identifiers in the order in which they are listed in § 3-104(g)(3)(i) of this title].

16 (2) The clerk shall rely on the instrument that is accompanied by the  
17 intake sheet for indexing of grantor's and grantee's names.

18 3-303.

19 The clerk shall [make a microfilm picture or other copy of every document he records  
20 and] transmit [the microfilm pictures or copies] **RECORDED DOCUMENTS** to the State  
21 Archivist [at the end of each year. When requested by the State Archivist, the clerk also  
22 shall make a microfilm picture or copy of the general index].

23 3-304.

24 (a) Except as provided in subsection (e) of this section, the clerk shall [fasten  
25 securely one copy of] **RECORD** each plat described under § 3-108 of this title [in a book  
26 provided for that purpose or shall record the plat].

27 (b) The clerk promptly shall send one copy of each plat to the supervisor of
