FOR the purpose of prohibiting a person from knowingly recruiting, harboring, transporting, or obtaining an individual for the purpose of appropriating the government benefits of an individual for the benefit of the person or another by certain means; prohibiting a person from knowingly benefitting in a certain manner from participation in a venture that violates a certain provision of this Act; prohibiting a person from aiding, abetting, or conspiring with one or more persons to violate a certain provision of this Act; and generally relating to benefits exploitation.
