1 AN ACT concerning

Public Safety - Statewide DNA Database System, DNA Collection, and Penalties Alterations

- 4 FOR the purpose of requiring a certain DNA sample to be collected in a certain manner $\mathbf{5}$ from an individual who is required to register as a sex offender; requiring a DNA 6 sample to be collected by a certain individual or at a certain location under certain 7 circumstances; requiring a custodial agency or correctional facility to ensure a DNA 8 sample is collected in a certain manner; prohibiting a DNA sample from being tested 9 and placed in a certain statewide DNA database system until certain conditions are 10 met; prohibiting an individual from refusing to provide a DNA sample as required for collection in the database system; requiring certain DNA samples or DNA records 11 to be destroyed and expunged under certain circumstances; and generally relating 1213 to the statewide DNA database system and the collection of DNA samples.
