- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- 16 (a) Except as otherwise provided in this section and after complying with § 6–305
- of this subtitle, in each year after the date of finality and before the following [July] **JUNE**
- 18 1, the Mayor and City Council of Baltimore City or the governing body of each county
- 19 annually shall set the tax rate for the next taxable year on all assessments of property
- 20 subject to that county's property tax.

- (a) (1) Except as provided in paragraph (2) of this subsection, in each year after the date of finality and before the following [July] **JUNE** 1, the governing body of each municipal corporation annually shall set the tax rate for the next taxable year on all assessments of property subject to municipal corporation property tax.
- 5 (2) If not otherwise prohibited by this article, the governing body of a municipal corporation may set special rates for any class of property that is subject to the municipal corporation property tax.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 9  $\,$  1, 2025.
