## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Cannabis – Sale and Distribution – Tetrahydrocannabinol Offenses**

3 FOR the purpose of authorizing the officers and employees of the Field Enforcement  
4 Division of the Alcohol, Tobacco, and Cannabis Commission to issue a citation for a  
5 certain violation; providing that the display or offering of tetrahydrocannabinol for  
6 sale is prima facie evidence of selling tetrahydrocannabinol; prohibiting the sale or  
7 distribution of certain products that contain tetrahydrocannabinol or are advertised  
8 as containing tetrahydrocannabinol; authorizing the Executive Director of the  
9 Commission to seize, destroy, or confiscate a certain unlawful product; and generally  
10 relating to the sale and distribution of tetrahydrocannabinol and related offenses.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
12 That the Laws of Maryland read as follows:

13 **Article – Alcoholic Beverages and Cannabis**

14 1–313.

15 (a) There is a Field Enforcement Division in the Office of the Executive Director.

16 (b) (1) The Field Enforcement Division may employ officers and employees as  
17 provided in the State budget.

18 (2) The officers and employees of the Field Enforcement Division:

19 (i) shall be sworn police officers;

20 (ii) shall have the powers, duties, and responsibilities of peace  
21 officers to enforce the provisions of this article relating to:

22 1. the unlawful importation of alcoholic beverages, tobacco,  
23 and cannabis into the State;

24 2. the unlawful manufacture of alcoholic beverages, tobacco,  
25 and cannabis in the State;

26 3. the transportation and distribution throughout the State  
27 of alcoholic beverages, tobacco, and cannabis that are manufactured illegally and on which  
28 any alcoholic beverages taxes, tobacco taxes, or cannabis taxes imposed by the State are  
29 due and unpaid; and

30 4. the manufacture, sale, barter, transportation,  
31 distribution, or other form of owning, handling, or dispersing alcoholic beverages, tobacco,  
32 or cannabis by any person not licensed or authorized under this article, provisions of the  
33 Tax – General Article relating to alcoholic beverages, tobacco, or cannabis, or provisions of  
34 the Business Regulation Article relating to alcoholic beverages, tobacco, or cannabis; [and]

1 (iii) **MAY ISSUE A CITATION OR OTHER CHARGING DOCUMENT TO**  
2 **A PERSON WHO HAS COMMITTED A VIOLATION OF § 10–108 OF THE CRIMINAL LAW**  
3 **ARTICLE; AND**

4 (IV) may make cooperative arrangements for and work and cooperate  
5 with the Office of the Comptroller, local State’s Attorneys, sheriffs, bailiffs, police, and other  
6 prosecuting and peace officers to enforce this article.

7 (c) The Field Enforcement Division:

8 (1) shall consult with and advise the local State’s Attorneys and other law  
9 enforcement officials and police officers regarding enforcement problems in their respective  
10 jurisdictions; and

11 (2) may recommend changes to improve the administration of this article,  
12 provisions of the Tax – General Article relating to alcoholic beverages, tobacco, and  
13 cannabis, and provisions of the Business Regulation Article relating to tobacco.

14 6–207.

15 (A) **IN THIS SECTION, “TETRAHYDROCANNABINOL” HAS THE MEANING**  
16 **STATED IN § 36–1102 OF THIS ARTICLE.**

17 (B) In a prosecution for selling alcoholic beverages **OR**  
18 **TETRAHYDROCANNABINOL** without an appropriate license, proof that the defendant  
19 displayed or offered alcoholic beverages **OR TETRAHYDROCANNABINOL** for sale, or kept  
20 a place of business where alcoholic beverages **OR TETRAHYDROCANNABINOL** were  
21 displayed or offered for sale, is prima facie evidence that the defendant sold alcoholic  
22 beverages **OR TETRAHYDROCANNABINOL**.

23 36–1102.

24 (a) (1) In this section the following words have the meanings indicated.

25 (2) “Hemp” has the meaning stated in § 14–401 of the Agriculture Article.

26 (3) “Tetrahydrocannabinol” means:

27 (i) any tetrahydrocannabinol, including  
28 delta–8–tetrahydrocannabinol, delta–9–tetrahydrocannabinol, and  
29 delta–10–tetrahydrocannabinol, regardless of how derived;

30 (ii) any other cannabinoid, except cannabidiol that the  
31 Administration determines to cause intoxication; and

1 (iii) any other chemically similar compound, substance, derivative, or  
2 isomer of tetrahydrocannabinol, as identified by the Administration.

3 (4) "Tincture" means a solution that is:

4 (i) dissolved in alcohol, glycerin, or vegetable oil; and

5 (ii) distributed in a dropper bottle of 4 ounces or less.

6 (b) (1) A person may not sell or distribute a product intended for human  
7 consumption or inhalation that contains more than 0.5 milligrams of tetrahydrocannabinol  
8 per serving or 2.5 milligrams of tetrahydrocannabinol per package unless the person is  
9 licensed under § 36–401 of this title and the product complies with the:

10 (i) manufacturing standards established under § 36–203 of this  
11 title;

12 (ii) laboratory testing standards established under § 36–203 of this  
13 title; and

14 (iii) packaging and labeling standards established under § 36–203 of  
15 this title.

16 (2) A person may not sell or distribute a product described under  
17 paragraph (1) of this subsection to an individual under the age of 21 years.

18 (c) A person may not sell or distribute a cannabinoid product that is not derived  
19 from naturally occurring biologically active chemical constituents.

20 (d) (1) Notwithstanding subsection (b) of this section and subject to paragraph  
21 (2) of this subsection, it is not a violation of this section for a person to sell or distribute a  
22 hemp–derived tincture intended for human consumption that contains:

23 (i) a ratio of cannabidiol to tetrahydrocannabinol of at least 15 to 1;  
24 and

25 (ii) 2.5 milligrams or less of tetrahydrocannabinol per serving and  
26 100 milligrams or less of tetrahydrocannabinol per package.

27 (2) To sell or distribute a hemp–derived tincture under this subsection, a  
28 person must provide, as required by the Administration, tincture samples for the purpose  
29 of testing to determine chemical potency and composition levels and to detect and quantify  
30 contaminants.

31 **36–1104.**

1 (A) IN THIS SECTION, “TETRAHYDROCANNABINOL” HAS THE MEANING  
2 STATED IN § 36–1102 OF THIS SUBTITLE.

3 (B) A PERSON MAY NOT SELL OR DISTRIBUTE A PRODUCT CONTAINING  
4 TETRAHYDROCANNABINOL THAT VIOLATES THE POTENCY, PACKAGING, OR  
5 LABELING REQUIREMENTS UNDER § 36–203 OR § 36–203.1 OF THIS TITLE OR ANY  
6 REGULATIONS ADOPTED UNDER THOSE SECTIONS.

7 (C) (1) A PERSON MAY NOT SELL OR DISTRIBUTE A PRODUCT THAT IS  
8 ADVERTISED AS CONTAINING AN AMOUNT OF TETRAHYDROCANNABINOL THAT  
9 VIOLATES § 36–1102 OF THIS SUBTITLE.

10 (2) ADVERTISING UNDER PARAGRAPH (1) OF THIS SUBSECTION  
11 INCLUDES PACKAGING, LABELING, OR ELECTRONIC COMMUNICATION.

12 (D) THE EXECUTIVE DIRECTOR MAY SEIZE, DESTROY, OR CONFISCATE A  
13 PRODUCT THAT IS:

14 (1) OFFERED OR DISPLAYED FOR SALE TO A CONSUMER IN A  
15 LOCATION THAT IS NOT APPROPRIATELY LICENSED UNDER SUBTITLE 4 OF THIS  
16 TITLE; AND

17 (2) THE SUBJECT OF A VIOLATION UNDER SUBSECTION (B) OR (C) OF  
18 THIS SECTION.

19 (E) (1) IF A PERSON WHO IS NOT A CANNABIS LICENSEE VIOLATES  
20 SUBSECTION (B) OR (C) OF THIS SECTION, THE PERSON:

21 (I) MAY BE CHARGED BY A CITATION; AND

22 (II) IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS  
23 SUBJECT TO A FINE NOT EXCEEDING \$5,000.

24 (2) IF A CANNABIS LICENSEE VIOLATES SUBSECTION (B) OR (C) OF  
25 THIS SECTION, THE LICENSEE IS SUBJECT TO DISCIPLINARY ACTION BY THE  
26 ADMINISTRATION IN ACCORDANCE WITH § 36–202 OF THIS TITLE.

27 **Article – Criminal Law**

28 10–108.

29 (a) A person who distributes products containing delta-8- or  
30 delta-10-tetrahydrocannabinol, including a person licensed under Title 16, Title 16.5, Title  
31 16.7, Title 16.9, or Title 17 of the Business Regulation Article, may not distribute, purchase

1 for sale, or sell a product containing delta-8- or delta-10-tetrahydrocannabinol to an  
2 individual under the age of 21 years.

3 (b) In a prosecution for a violation of this section, it is a defense that the defendant  
4 examined the purchaser's or recipient's driver's license, or other valid identification issued  
5 by a governmental unit, that positively identified the purchaser or recipient as being at  
6 least 21 years old.

7 (c) Any website owned, managed, or operated by a person who distributes or sells  
8 a product containing delta-8- or delta-10-tetrahydrocannabinol shall employ a neutral  
9 age-screening mechanism that verifies that the user is at least 21 years old, including by  
10 using an age-gate, age-screen, or age-verification mechanism.

11 (d) A person who violates this section is guilty of a misdemeanor and on conviction  
12 is subject to a fine not exceeding:

13 (1) \$300 for a first violation;

14 (2) \$1,000 for a second violation occurring within 2 years after the first  
15 violation; and

16 (3) \$3,000 for each subsequent violation occurring within 2 years after the  
17 preceding violation.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
19 1, 2025.
