## A BILL ENTITLED

1 AN ACT concerning

2 **Public Health – Cannabis Public Health Advisory Council – Membership**

3 FOR the purpose of altering the membership of the Cannabis Public Health Advisory  
4 Council; and generally relating to the Cannabis Public Health Advisory Council.

5 BY repealing and reenacting, without amendments,  
6 Article – Health – General  
7 Section 13–4502(a)

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
16 That the Laws of Maryland read as follows:

17 **Article – Health – General**

18 13–4502.

19 (a) There is a Cannabis Public Health Advisory Council.

20 (b) The Advisory Council consists of the following members:

21 (1) One member from the Senate of Maryland, appointed by the President  
22 of the Senate;

2 the House;
- 3 (3) The Secretary, or the Secretary's designee;
- 4 (4) The Deputy Secretary for Behavioral Health, or the Deputy Secretary's  
5 designee;
- 6 (5) The Secretary of Agriculture, or the Secretary's designee;
- 7 (6) The Executive Director of the [Natalie M. LaPrade Medical Cannabis  
8 Commission] **MARYLAND CANNABIS ADMINISTRATION**, or the Executive Director's  
9 designee;
- 10 (7) The State Superintendent of Schools, or the State Superintendent's  
11 designee;
- 12 (8) The Executive Director of the Governor's Office of Crime Prevention  
13 and Policy, or the Executive Director's designee; [and]
- 14 (9) **THE ADMINISTRATOR OF THE MOTOR VEHICLE**  
15 **ADMINISTRATION, OR THE ADMINISTRATOR'S DESIGNEE; AND**
- 16 **(10)** The following members appointed by the Governor:
- 17 (i) One representative from a historically black college or  
18 university;
- 19 (ii) One health care provider with experience in cannabis;
- 20 (iii) One pharmacist licensed in the State;
- 21 (iv) One health care provider with expertise in substance use  
22 disorder treatment and recovery;
- 23 (v) One individual with expertise in cannabis use disorder;
- 24 (vi) One academic researcher with expertise in cannabis law and  
25 policy;
- 26 (vii) One individual with at least 5 years of experience in health or  
27 social equity;
- 28 (viii) One public health professional with cannabis experience; and

1                                   (ix) One representative of a laboratory that tests cannabis.

2                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
3   October 1, 2025.
