(a) 2 There is a Maryland Veterans Trust established for the purpose of 3 providing monetary and other assistance to: 4 (i) veterans and their families: [and] 5 (ii) MEMBERS OF THE MARYLAND NATIONAL GUARD AND 6 THEIR FAMILIES; AND 7 public and private programs that support veterans and their (III) families. 8 9 (2) There is a Maryland Veterans Trust Fund. Money in the Fund may only be used to: 10 (e) make grants and loans under § 9–914.2(a)(3) of this subtitle; 11 (1) 12 be invested under § 9–914.3(b) of this subtitle; and (2) 13 pay the costs of administering the Fund through distribution to an 14 administrative cost account in the Department. 9-914.2. 15 16 The Trust shall have the powers and duties to: (a) 17 (3) expend money from the Fund to provide grants or loans to: veterans and their families: 18 (i) MEMBERS OF THE MARYLAND NATIONAL GUARD AND 19 (ii) 20 THEIR FAMILIES; 21(III) public and private programs that support veterans and their 22families; or 23[(iii)] (IV) any other programs that the Trust considers to be within the purpose for which the Trust is established; 24SECTION 2.
