# A BILL ENTITLED

## 1 AN ACT concerning

# Natural Resources – Fishing Licenses and Stamps – Alterations

FOR the purpose of altering the fees for resident consolidated senior sport fishing licenses,
angler's licenses, and trout stamps; repealing the exemption from the requirement
to obtain a trout stamp under certain circumstances for a holder of a resident
consolidated senior sport fishing license; and generally relating to fishing licenses
and stamps.

17 (a) The Department shall establish a resident consolidated senior sport fishing 18 license, to be issued to residents of Maryland beginning in the calendar year in which they 19 attain the age of 65.
