A BILL ENTITLED

1 AN ACT concerning

2 **Educational Equality for Service Members Act**

3 FOR the purpose of establishing rules of interpretation related to the uniformed services;
4 altering the rule of interpretation for “veteran”; altering the application of certain
5 provisions of law governing education to apply to all uniformed services, rather than
6 only the armed forces; and generally relating to veterans and uniformed services.

18 (a) In this article, unless the context requires otherwise, the following words have
19 the meanings indicated.

20 (A–1) “ACTIVE DUTY” HAS THE MEANING STATED IN § 9–901 OF THE STATE
21 GOVERNMENT ARTICLE.

22 (A–2) “ACTIVE SERVICE MEMBER” HAS THE MEANING STATED IN § 9–901 OF
23 THE STATE GOVERNMENT ARTICLE.

24 (B–1) “ARMED FORCES” HAS THE MEANING STATED IN § 9–901 OF THE STATE
25 GOVERNMENT ARTICLE.

26 (K–1) “RESERVE COMPONENT” HAS THE MEANING STATED IN § 9–901 OF THE
27 STATE GOVERNMENT ARTICLE.

28 (N) “UNIFORMED SERVICES” HAS THE MEANING STATED IN § 9–901 OF THE
29 STATE GOVERNMENT ARTICLE.

2 (9) “Serious family hardship” means:

3 (vi) Assignment of a parent or legal guardian of a child to active
4 **[military] UNIFORMED SERVICES** duty.

7 return from **[military services] SERVICE IN THE UNIFORMED SERVICES** in § 1–203 of the
8 Local Government Article.

10 (a) (1) In this section the following words have the meanings indicated.

11 (2) (i) **[“Military] “ELIGIBLE spouse”** means the spouse of **[a] AN**
12 **ACTIVE** service member or **ELIGIBLE** veteran.

13 (ii) **[“Military] “ELIGIBLE spouse”** includes a surviving spouse of:

14 1. **[A] AN ELIGIBLE** veteran; or

15 2. **[A] AN ACTIVE** service member who died within 1 year
16 before the date on which the application for an educator certificate is submitted.

17 **[(3) “Service member”** means an individual who is an active duty member
18 of:

19 (i) The armed forces of the United States;

20 (ii) A reserve component of the armed forces of the United States; or

21 (iii) The National Guard of any state.

23 from active duty under circumstances other than dishonorable within 1 year before the date
24 on which the application for an educator certificate is submitted.

26 active duty and has been discharged for more than 1 year before the application for an
27 educator certificate is submitted.]

1 **(3) (I) “ELIGIBLE VETERAN” MEANS A VETERAN WHO WAS**
2 **DISCHARGED FROM ACTIVE DUTY WITHIN 1 YEAR BEFORE THE DATE ON WHICH THE**
3 **APPLICATION FOR AN EDUCATOR CERTIFICATE IS SUBMITTED.**

4 **(II) “ELIGIBLE VETERAN” DOES NOT INCLUDE A VETERAN WHO**
5 **HAS BEEN DISCHARGED FROM ACTIVE DUTY FOR MORE THAN 1 YEAR BEFORE THE**
6 **APPLICATION FOR AN EDUCATOR CERTIFICATE IS SUBMITTED.**

7 (b) The State Superintendent shall expedite educator certification for [a] AN
8 ACTIVE service member, ELIGIBLE veteran, or [military] ELIGIBLE spouse.

9 (c) To qualify for expedited educator certification under this section, [a] AN
10 ACTIVE service member, ELIGIBLE veteran, or [military] ELIGIBLE spouse shall:

11 (1) Submit an application for educator certification;

12 (2) Hold a valid educator license or certificate in good standing issued in
13 another state;

14 (3) Meet the applicable qualifications for certification in COMAR
15 13A.12.01.04 and .05; and

16 (4) Pay the applicable certification fee.

17 (d) (1) Subject to paragraph (2) of this subsection, the State Superintendent,
18 at the request of a local school system, may issue a temporary educator certificate to [a] AN
19 ACTIVE service member, ELIGIBLE veteran, or [military] ELIGIBLE spouse who holds a
20 valid educator certificate or license in good standing issued in another state but who does
21 not meet the qualifications for educator certification in this State.

22 (2) A temporary educator certificate issued under this subsection
23 authorizes the ACTIVE service member, ELIGIBLE veteran, or [military] ELIGIBLE spouse,
24 for a limited period of time, as determined by the State Superintendent, to be employed as
25 an educator in the State while the ACTIVE service member, ELIGIBLE veteran, or
26 [military] ELIGIBLE spouse completes additional requirements for certification in this
27 State.

28 (e) The Department shall publish prominently on its website the process for
29 obtaining expedited educator certification under this section.

30 (f) The State Board may adopt regulations to carry out this section.

32 (b) (2) (i) [Upon] ON request and in accordance with a county board’s
33 policies concerning residency, a county superintendent:

1 1. May allow a child to attend school in the county even if the
2 child is not domiciled in that county with the child’s parent or guardian; and

3 2. Shall allow a dependent child of [a] AN ACTIVE service
4 member who is relocating to the State on [military] OFFICIAL orders to enroll in school in
5 the county in accordance with § 7–115.1 of this subtitle.

6 (c) (1) (i) In this subsection the following words have the meanings
7 indicated.

8 (iv) “Serious family hardship” means:

9 6. Assignment of a parent or legal guardian of a child to
10 active [military] UNIFORMED SERVICES duty.

(a) (1) In this section the following words have the meanings indicated.

(2) "Dependent child" means an individual of school age who is a natural child, a stepchild, an adopted child, or a financially dependent child of [a] **AN ACTIVE** service member.

1 (3) “Enrollment” includes course registration and charter school lotteries.

2 [(4) (i) “Service member” means an active duty member of the United
3 States armed forces.

4 (ii) “Service member” includes a member of the National Guard on
5 active duty orders.]

6 (b) A county superintendent shall allow a dependent child of [a] **AN ACTIVE**
7 service member who is relocating to the State on [military] **OFFICIAL** orders and is not
8 domiciled in that county during the enrollment period to apply for enrollment in a public
9 school in the county, in the same manner and at the same time as individuals domiciled in
10 the county.

11 (c) (1) Within 10 days of the published arrival date on the **ACTIVE** service
12 member’s [military] **OFFICIAL** orders, the **ACTIVE** service member shall provide the school
13 with:

14 (i) Satisfactory evidence of the dependent child’s status as a
15 dependent child of the **ACTIVE** service member;

16 (ii) A copy of the **ACTIVE** service member’s [military] **OFFICIAL**
17 orders to relocate; and

18 (iii) Proof of residence in the county.

19 (2) The **ACTIVE** service member may use the address of any of the following
20 as proof of residence:

21 (i) A temporary on–base lodging facility;

22 (ii) A purchased or leased home or apartment; or

23 (iii) Any federal government housing unit or off–base military
24 housing unit.

26 (a) (1) In this section the following words have the meanings indicated.

27 (2) “Military–connected student” means a student who is a dependent of:

28 (i) [A current] **AN ACTIVE DUTY UNIFORMED SERVICES** member
29 [of:

1 1. The United States military serving in the Army, Navy, Air
2 Force, Marine Corps, Space Force, or Coast Guard on active duty;

3 2. The Maryland National Guard or the National Guard of
4 any other state; or

5 3. A reserve force of the United States military];

6 **(II) A MEMBER OF A RESERVE COMPONENT; or**

7 **[(ii)] (III)** A member [of a military or reserve force] described in item
8 **(i) OR (II)** of this paragraph who was killed in the line of duty.

17 (1) Designate a staff member as a [military] **UNIFORMED SERVICES**

20 or soon to be enrolled at the school;

21 (ii) Serving as the point of contact between the school and newly
22 enrolled or soon to be enrolled military–connected students and their families;

23 (iii) Determining appropriate school services available to newly
24 enrolled or soon to be enrolled military–connected students;

25 (iv) Assisting in coordinating school programs for newly enrolled or
26 soon to be enrolled military–connected students; and

27 (v) Generally aiding with a military–connected student’s transition

18 (i) Was honorably discharged from the [United States armed forces]
19 **UNIFORMED SERVICES**; and

20 (ii) 1. Resides in this State; or

21 2. Is domiciled in this State; or

22 (4) The National Guard member described in subsection (a) of this section
23 is a member of the Maryland National Guard and joined or subsequently serves in the
24 Maryland National Guard to:

25 (i) Provide a Critical Military Occupational Skill; or

26 (ii) Be a member of the Air Force Critical Specialty Code as
27 determined by the National Guard.

29 (a) In this section, “eligible service member” means:

1 (1) [A currently serving member of any branch of the armed forces of the
2 United States, including the National Guard and the military reserves] **AN ACTIVE**
3 **SERVICE MEMBER**; and

5 including the National Guard and the military reserves, who has received an honorable
