BY repealing and reenacting, without amendments, Article – Alcoholic Beverages and Cannabis Section 12–102 and 12–2007 Annotated Code of Maryland (2024 Replacement Volume) BY adding to Article – Alcoholic Beverages and Cannabis Section 12–2802(f) Annotated Code of Maryland (2024 Replacement Volume) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. That the Laws of Maryland read as follows: Article - Alcoholic Beverages and Cannabis

- 2 This title applies only in Baltimore City.
- 3 12–2007.
- 4 (a) Except as provided in subsection (b) of this section, a licensed premises shall end all operations, including the serving of alcoholic beverages and food and providing entertainment, at the closing hour for that class of licensed premises specified in this title.
- 7 (b) (1) The Board may grant an exemption for remaining open after hours to:
- 8 (i) a holder of a Class B restaurant license, only for serving food to 9 patrons seated for dining;
- 10 (ii) a pharmacy that fills prescriptions; or
- 11 (iii) a holder of a Class D beer, wine, and liquor license that operates 12 a restaurant, if:
- 13 1. it is used only for serving food to patrons seated in a dining 14 room that is not adjacent to a bar; and
- 15 2. the restaurant is located in the 46th legislative district in 16 the Legislative Districting Plan of 2022.
- 17 (2) A pharmacy that receives an exemption under paragraph (1) of this subsection may also sell products other than alcohol after normal closing hours.
- 19 (3) A hotel that holds a Class B license and that serves food to seated 20 customers or for private functions or guest rooms may continue to provide food service.
- 21 (4) The Board may waive the requirement in paragraph (1)(iii)1 of this 22 subsection that a dining room not be adjacent to a bar.
