### 2 Motor Vehicles – Secondary Enforcement and Admissibility of Evidence

3 FOR the purpose of requiring a police officer to document all reasons for a traffic stop or 4 other stop on a citation or police report resulting from the stop; establishing that  $\mathbf{5}$ certain evidence obtained during a traffic stop or other stop in violation of certain 6 provisions may be or is inadmissible in certain proceedings; authorizing a police 7 officer to enforce certain provisions of the Maryland Vehicle Law only as a secondary 8 action; establishing a police officer's failure to comply with the provisions of this Act 9 as a basis for administrative disciplinary action; and generally relating to police 10stops.
