# Baltimore City – Alcoholic Beverages – 45th Alcoholic Beverages District – Licenses

FOR the purpose of authorizing the Board of License Commissioners for Baltimore City to
issue a Class C beer, wine, and liquor license in a certain area of the 45th alcoholic
beverages district in Baltimore City under certain circumstances; altering a
geographic boundary in the 45th district within which the holder of a Class A or
Class B-D-7 beer, wine, and liquor license must operate in accordance with specified
hours; and generally relating to alcoholic beverages in Baltimore City.
