CHAPTER _____

1 AN ACT concerning

2 **Election Law – Chief Election Judges – Party Affiliation**

3 FOR the purpose of requiring the election director of a local board of elections to designate
4 chief election judges from certain political parties to each polling place except under
5 certain circumstances; and generally relating to the party affiliation of chief election
6 judges.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Election Law**

20 10–201.

1 (a) (1) (i) Except as provided in subparagraph (ii) of this paragraph, each
2 local board shall provide at least four election judges to be the staff for each polling place.

3 (ii) In a precinct with fewer than 200 registered voters, the local
4 board may provide two election judges for that precinct's polling place.

5 (2) An election judge shall be appointed in accordance with the
6 requirements of § 10–203 of this subtitle.

7 (b) (1) Except as provided in [paragraph] PARAGRAPHS (2) AND (3) of this
8 subsection, **TO THE EXTENT PRACTICABLE**, each polling place shall have an equal
9 number of election judges, **INCLUDING CHIEF JUDGES DESIGNATED UNDER § 10–203**
10 **OF THIS SUBTITLE**, from:

11 (i) the majority party; and

12 (ii) the principal minority party.

13 (2) [(i)] If the total number of election judges for a precinct is six or more:

14 [1.] (I) a local board may provide one or more election
15 judges who are not registered with either the majority party or principal minority political
16 party; and

17 [2.] (II) a local board may provide one or more election
18 judges who are minors.

19 [(ii)] The number of election judges provided under this paragraph
20 may not exceed the lesser of:

21 1. the number of election judges who belong to the majority
22 party; or

23 2. the number of election judges who belong to the principal
24 minority party.]

25 (3) (I) **THIS PARAGRAPH APPLIES IF AN ELECTION DIRECTOR IS**
26 **UNABLE TO DESIGNATE CHIEF JUDGES FOR A POLLING PLACE AT LEAST 45 DAYS**
27 **BEFORE THE START OF EARLY VOTING.**

28 (II) **IF AN ELECTION DIRECTOR DESIGNATING TWO CHIEF**
29 **JUDGES FOR A POLLING PLACE UNDER § 10–203 OF THIS SUBTITLE IS UNABLE TO**
30 **DESIGNATE THE CHIEF JUDGES IN ACCORDANCE WITH PARAGRAPH (1) OF THIS**
31 **SUBSECTION, AN ELECTION DIRECTOR SHALL DESIGNATE:**

1 **1. ONE CHIEF JUDGE FROM THE MAJORITY PARTY OR**
2 **THE PRINCIPAL MINORITY POLITICAL PARTY; AND**

3 **2. ONE CHIEF JUDGE WHO IS NOT REGISTERED WITH**
4 **EITHER THE MAJORITY PARTY OR THE PRINCIPAL MINORITY POLITICAL PARTY.**

6 (a) The election director, with the approval of the local board, shall appoint the
7 election judges for each polling place for a term that begins on the Tuesday that is 13 weeks
8 before each statewide primary election.

9 (b) One or two election judges in each precinct shall:

10 (1) be designated chief judge; and

11 (2) supervise the staff at the polling place.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 October 1, 2025.
