- 4 (a) A person may not knowingly conduct or attempt to conduct a bazaar or raffle in violation of §§ 13–503 through 13–505 **AND 13–505.1** of this subtitle.
- 6 (b) A person who violates this section is guilty of a misdemeanor and on conviction 7 is subject to imprisonment not exceeding 1 year or a fine not exceeding \$1,000 or both.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2025. It shall remain effective for a period of 3 years 1 year and 1 month and, at the end of May 31, 2028 June 30, 2026, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
