## A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City – Raffles – Organizations Affiliated With a Professional Major**  
3 **League Baseball Team**

4 FOR the purpose of authorizing certain organizations that are affiliated with a professional  
5 major league baseball team that plays its home games in Baltimore City to conduct  
6 certain raffles; requiring the organization to obtain a permit to conduct raffles from  
7 an agency designated by the Baltimore City government; authorizing a raffle ticket  
8 to be sold and received on an electronic device located within the geographical  
9 boundaries of Baltimore City; and generally relating to raffles in Baltimore City.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
21 That the Laws of Maryland read as follows:

22 **Article – Criminal Law**

23 13–501.

24 (a) In this subtitle the following words have the meanings indicated.

1 (b) “Commissioner” means the Baltimore City Police Commissioner.

2 (c) **“DESIGNATED CITY AGENCY” MEANS AN AGENCY DESIGNATED BY THE**  
3 **BALTIMORE CITY GOVERNMENT.**

4 (d) (1) **“ELECTRONIC DEVICE” MEANS A DEVICE THAT IS CAPABLE OF**  
5 **TRANSMITTING, RECEIVING, OR RECORDING MESSAGES, IMAGES, SOUNDS, DATA, OR**  
6 **OTHER INFORMATION BY ELECTRONIC MEANS OR THAT, IN APPEARANCE,**  
7 **PURPORTS TO BE A CELL PHONE, COMPUTER, OR OTHER SUCH DEVICE.**

8 (2) **“ELECTRONIC DEVICE” INCLUDES A CELL PHONE OR COMPUTER.**

9 (3) **“ELECTRONIC DEVICE” DOES NOT INCLUDE A VIDEO LOTTERY**  
10 **TERMINAL AS DEFINED UNDER § 9–1A–01 OF THE STATE GOVERNMENT ARTICLE.**

11 [(c)] (e) “Gaming event” means a carnival, bazaar, or raffle.

12 (f) (1) **“GEOFENCE” MEANS TECHNOLOGY THAT ESTABLISHES A**  
13 **VIRTUAL GEOGRAPHICAL BOUNDARY.**

14 (2) **“GEOFENCE” INCLUDES BOUNDARIES THAT ARE ESTABLISHED**  
15 **OR MONITORED THROUGH THE USE OF:**

16 (i) **GLOBAL POSITIONING TECHNOLOGY;**

17 (ii) **CELL TOWER CONNECTIVITY;**

18 (iii) **CELLULAR DATA;**

19 (iv) **RADIO FREQUENCY IDENTIFICATION;**

20 (v) **WIRELESS FIDELITY TECHNOLOGY; OR**

21 (vi) **ANY OTHER FORM OF LOCATION DETERMINATION**  
22 **TECHNOLOGY.**

23 [(d)] (g) “Raffle” means one or more drawings from a single series of chances  
24 sold [from chance books].

25 13–503.

26 (a) **THIS SECTION DOES NOT APPLY TO A RAFFLE AUTHORIZED UNDER §**  
27 **13–505.1 OF THIS SUBTITLE.**

1           **(B)** Before an organization listed in subsection **[(b)] (C)** of this section may operate  
2 a gaming event, the organization shall obtain a permit from the commissioner.

3           **[(b)] (C)** (1) An organization that meets the conditions of paragraph (2) of this  
4 subsection may conduct a gaming event for the benefit of any of the following listed  
5 organizations if the organization is a bona fide:

6                           (i) religious organization;

7                           (ii) fraternal organization;

8                           (iii) civic organization;

9                           (iv) veterans' hospital;

10                           (v) amateur athletic organization in which all playing members are  
11 under the age of 18 years; or

12                           (vi) charitable organization.

13           (2) An organization conducting a gaming event shall:

14                           (i) be located in Baltimore City; and

15                           (ii) spend a majority of the organization's funds in Baltimore City  
16 for:

17                                   1. fraternal purposes;

18                                   2. civic purposes;

19                                   3. purposes related to a veterans' hospital;

20                                   4. purposes related to amateur athletics; or

21                                   5. charitable purposes.

22           **[(c)] (D)** (1) Before the commissioner may issue a permit, the commissioner  
23 shall review the character of the organization applying for the permit to ascertain that the  
24 organization meets the requirements of §§ 13-503 through 13-505 of this subtitle.

25                           (2) The commissioner shall make any application for a permit and the  
26 action taken by the commissioner on that application a matter of public record.

27           **[(d)] (E)** (1) The permit shall state that the gaming event shall be managed  
28 and operated personally only by members of the organization obtaining the permit.

1 (2) The permit is not transferable.

2 [(e)] (F) An organization conducting a gaming event in Baltimore City may not  
3 allow an individual or group of individuals to:

4 (1) benefit financially from the gaming event; or

5 (2) receive any of the proceeds of the gaming event for personal use or  
6 benefit.

7 13-505.

8 (a) A permit holder may award prizes in merchandise and money in a raffle in  
9 any amount.

10 (b) [A] EXCEPT AS PROVIDED IN § 13-505.1(D)(1)(II) OF THIS SUBTITLE, A  
11 permit holder may not conduct more than 12 raffles in a calendar year.

12 **13-505.1.**

13 (A) A RAFFLE MAY BE CONDUCTED BY AN ORGANIZATION THAT:

14 (1) IS LOCATED IN BALTIMORE CITY;

15 (2) SPENDS A MAJORITY OF THE ORGANIZATION'S FUNDS IN  
16 BALTIMORE CITY FOR:

17 (I) FRATERNAL PURPOSES;

18 (II) CIVIC PURPOSES;

19 (III) PURPOSES RELATED TO A VETERANS' HOSPITAL;

20 (IV) PURPOSES RELATED TO AMATEUR ATHLETICS; OR

21 (V) CHARITABLE PURPOSES; AND

22 (3) IS AFFILIATED WITH A PROFESSIONAL MAJOR LEAGUE BASEBALL  
23 TEAM THAT PLAYS ITS HOME GAMES IN BALTIMORE CITY.

24 (B) (1) BEFORE CONDUCTING A RAFFLE, AN ORGANIZATION SHALL  
25 OBTAIN A WRITTEN PERMIT FROM THE DESIGNATED CITY AGENCY.

1           **(2) BEFORE ISSUING A PERMIT, THE DESIGNATED CITY AGENCY**  
2 **SHALL ASCERTAIN THE CHARACTER OF THE ORGANIZATION TO DETERMINE IF THE**  
3 **PERMIT SHOULD BE ISSUED.**

4           **(C) (1) A PERMIT ISSUED TO AN ORGANIZATION UNDER THIS SECTION**  
5 **MAY NOT BE TRANSFERRED.**

6           **(2) THE PERMIT SHALL STATE THAT THE RAFFLE IS REQUIRED TO BE**  
7 **MANAGED AND OPERATED ONLY BY MEMBERS OF THE ORGANIZATION OBTAINING**  
8 **THE PERMIT.**

9           **(D) (1) (I) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE**  
10 **DESIGNATED CITY AGENCY MAY ISSUE A SINGLE PERMIT TO AN ORGANIZATION TO**  
11 **HOLD RAFFLES AT MULTIPLE PROFESSIONAL MAJOR LEAGUE BASEBALL GAMES**  
12 **PLAYED IN BALTIMORE CITY.**

13                           **(II) THERE IS NO LIMIT ON THE NUMBER OF RAFFLES THAT AN**  
14 **ORGANIZATION MAY CONDUCT IN CONJUNCTION WITH PROFESSIONAL MAJOR**  
15 **LEAGUE BASEBALL GAMES PLAYED IN BALTIMORE CITY.**

16           **(2) A PERMIT TO HOLD RAFFLES AT MULTIPLE PROFESSIONAL**  
17 **MAJOR LEAGUE BASEBALL GAMES PLAYED IN BALTIMORE CITY EXPIRES AT THE**  
18 **END OF THE CALENDAR YEAR IN WHICH THE PERMIT IS ISSUED.**

19           **(E) AN ORGANIZATION CONDUCTING A RAFFLE MAY:**

20                   **(1) SET THE PRICE OF RAFFLE TICKETS; AND**

21                   **(2) AWARD PRIZES IN MERCHANDISE AND MONEY IN ANY AMOUNT.**

22           **(F) AN ORGANIZATION CONDUCTING A RAFFLE MAY NOT:**

23                   **(1) BENEFIT FINANCIALLY FROM THE RAFFLE; OR**

24                   **(2) RECEIVE ANY OF THE PROCEEDS OF THE RAFFLE FOR PERSONAL**  
25 **USE OR BENEFIT.**

26           **(G) (1) A RAFFLE TICKET SOLD BY AN ORGANIZATION IN CONJUNCTION**  
27 **WITH A PROFESSIONAL MAJOR LEAGUE BASEBALL GAME PLAYED IN BALTIMORE**  
28 **CITY:**

29                           **(I) MAY BE SOLD AND RECEIVED ON AN ELECTRONIC DEVICE**  
30 **ONLY WITHIN THE GEOGRAPHICAL BOUNDARIES OF BALTIMORE CITY; AND**

1                   **(II) SHALL BE SOLD AND RECEIVED NOT EARLIER THAN 1 HOUR**  
2 **BEFORE THE OFFICIAL START OF THE BASEBALL GAME AND NOT LATER THAN THE**  
3 **SEVENTH INNING OF THAT BASEBALL GAME.**

4                   **(2) AN ORGANIZATION CONDUCTING A RAFFLE UNDER THIS SECTION**  
5 **SHALL USE A GEOFENCE TO ENSURE THAT RAFFLE TICKETS SOLD AND RECEIVED ON**  
6 **AN ELECTRONIC DEVICE ARE SOLD AND RECEIVED WITHIN THE GEOGRAPHICAL**  
7 **BOUNDARIES OF BALTIMORE CITY.**

8 13-510.

9           (a) A person may not knowingly conduct or attempt to conduct a bazaar or raffle  
10 in violation of §§ 13-503 through 13-505 **AND 13-505.1** of this subtitle.

11           (b) A person who violates this section is guilty of a misdemeanor and on conviction  
12 is subject to imprisonment not exceeding 1 year or a fine not exceeding \$1,000 or both.

13           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
14 1, 2025.
