A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicles – Automated Enforcement Programs – Privacy Protections**

3 FOR the purpose of requiring a custodian of recorded images produced by certain
4 automated enforcement systems to deny inspection of the recorded images, subject
5 to certain exceptions; prohibiting certain State and local agencies from using a
6 recorded image or associated data produced by an automated enforcement system
7 without a warrant, subpoena, or court order unless the use is for an appropriate
8 traffic enforcement purpose; establishing certain requirements and authorizations
9 for the removal and destruction of recorded images and associated data produced by
10 an automated enforcement system; establishing certain prohibitions and
11 requirements for privacy protection under automated enforcement programs; and
12 generally relating to privacy protections for automated enforcement programs.

19 (3) **AN EMPLOYEE OR A CONTRACTOR OF AN AGENCY MAY ACCESS**
20 **AND USE A RECORDED IMAGE AND ASSOCIATED DATA:**

21 (i) **TO AUDIT OR EVALUATE THE ACCURACY OF THE**
22 **AUTOMATED ENFORCEMENT SYSTEM; AND**

23 (ii) **IN A MANNER CONSISTENT WITH SUBSECTION (D) OF THIS**
24 **SECTION.**

25 (4) **AN AGENCY THAT KNOWINGLY VIOLATES THIS SUBSECTION IS**
26 **SUBJECT TO A FINE NOT EXCEEDING \$1,000 FOR EACH VIOLATION.**

27 (d) (1) **AN AGENCY SHALL IMMEDIATELY REMOVE FROM ITS RECORDS**
28 **AND DESTROY ANY RECORDED IMAGE OR ASSOCIATED DATA CAPTURED UNDER A**
29 **PROGRAM THAT DOES NOT CONSTITUTE EVIDENCE OF A VIOLATION.**

1 **(2) A RECORDED IMAGE OR ASSOCIATED DATA CAPTURED UNDER A**
2 **PROGRAM THAT CONSTITUTES EVIDENCE OF A VIOLATION MAY BE RETAINED ONLY**
3 **FOR UP TO 6 MONTHS OR UNTIL THE CONCLUSION OF ANY CRIMINAL INVESTIGATION**
4 **OR CRIMINAL OR CIVIL COURT ACTION INVOLVING THE RECORDED IMAGE OR**
5 **ASSOCIATED DATA.**

6 **(3) BEFORE AN AGENCY REMOVES AND DESTROYS A RECORDED**
7 **IMAGE OR ASSOCIATED DATA, THE AGENCY MAY DISAGGREGATE THE DATA FOR**
8 **ANALYSIS PURPOSES IN A MANNER THAT DOES NOT IDENTIFY ANY INDIVIDUAL OR**
9 **VEHICLE.**

10 **(E) (1) AN AGENCY THAT IMPLEMENTS AND OPERATES A PROGRAM**
11 **SHALL ADOPT PROCEDURES RELATING TO THE OPERATION OF THE PROGRAM AND**
12 **THE USE OF AUTOMATED ENFORCEMENT SYSTEMS.**

13 **(2) THE PROCEDURES SHALL:**

14 **(I) IDENTIFY THE EMPLOYEE CLASSIFICATIONS IN THE**
15 **AGENCY THAT HAVE AUTHORIZATION TO ACCESS OR USE RECORDED IMAGES AND**
16 **ASSOCIATED DATA PRODUCED BY AN AUTOMATED ENFORCEMENT SYSTEM;**

17 **(II) ESTABLISH AN AUDIT PROCESS TO ENSURE THAT**
18 **INFORMATION OBTAINED THROUGH THE USE OF AN AUTOMATED ENFORCEMENT**
19 **SYSTEM IS USED ONLY FOR APPROPRIATE TRAFFIC ENFORCEMENT PURPOSES AS**
20 **AUTHORIZED IN THIS SECTION;**

21 **(III) ESTABLISH PROCEDURES AND SAFEGUARDS TO ENSURE**
22 **THAT AGENCY PERSONNEL WITH ACCESS TO RECORDED IMAGES AND ASSOCIATED**
23 **DATA ARE ADEQUATELY SCREENED AND TRAINED;**

24 **(IV) ESTABLISH PROCEDURES AND SAFEGUARDS FOR THE**
25 **SECURE STORAGE OF THE RECORDED IMAGES AND ASSOCIATED DATA BEFORE THE**
26 **IMAGES AND DATA ARE REMOVED AND DESTROYED; AND**

27 **(V) ESTABLISH PROCEDURES FOR THE REMOVAL AND**
28 **DESTRUCTION OF RECORDED IMAGES AND ASSOCIATED DATA.**

29 **(F) (1) RECORDED IMAGES AND ASSOCIATED DATA SHALL BE STORED**
30 **USING SOFTWARE THAT IS INDEPENDENT FROM AND INACCESSIBLE TO OTHER**
31 **SYSTEMS AND NETWORKS.**

32 **(2) AN AUTOMATED ENFORCEMENT SYSTEM SHALL BE SITUATED AND**
33 **FOCUSED IN A MANNER THAT:**

1 **(I) CAPTURES RECORDED IMAGES AND ASSOCIATED DATA OF**
2 **VIOLATIONS; AND**

3 **(II) TO THE MAXIMUM EXTENT POSSIBLE, DOES NOT CAPTURE**
4 **IDENTIFYING IMAGES OF THE DRIVER, OTHER DRIVERS OR VEHICLES, OR**
5 **PEDESTRIANS.**

6 **(3) AN AUTOMATED ENFORCEMENT SYSTEM MAY NOT USE**
7 **BIOMETRIC IDENTIFYING TECHNOLOGY, INCLUDING FACIAL RECOGNITION**
8 **TECHNOLOGY.**

9 **(4) (I) AN AGENCY OR A CONTRACTOR OF AN AGENCY MAY NOT**
10 **SELL OR OTHERWISE TRANSFER OR SHARE RECORDED IMAGES AND ASSOCIATED**
11 **DATA WITH ANOTHER PERSON OTHER THAN:**

12 **1. A PERSON ALLEGED TO BE LIABLE FOR A CIVIL**
13 **VIOLATION RECORDED BY AN AUTOMATED ENFORCEMENT SYSTEM;**

14 **2. A COURT OF COMPETENT JURISDICTION WHEN**
15 **ADJUDICATING LIABILITY; OR**

8 recorded by an automated railroad grade crossing enforcement system during the
9 commission of a violation.

11 County and Prince George's County, the Chief Judge of the District Court shall adopt
12 procedures for the issuance of citations, the trial of violations, and the collection of civil
13 penalties under this section.

23 District Court shall adopt procedures for the issuance of citations, trials for violations, and

27 miles per hour or greater.
