1 AN ACT concerning

2 **State Department of Education – Soccer Opportunities Program –**
3 **Establishment**

4 FOR the purpose of establishing the Soccer Opportunities Program in the State
5 Department of Education to increase opportunities for minority students to
6 participate in soccer in their communities; and generally relating to the Soccer
7 Opportunities Program.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Education**

16 **2–305.1.**

17 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
18 **INDICATED.**

19 **(2) “MINORITY STUDENT” HAS THE MEANING STATED IN**
20 **REGULATIONS ADOPTED BY THE STATE SUPERINTENDENT.**

21 **(3) “YOUTH SOCCER NONPROFIT ORGANIZATION” MEANS A**
22 **NONPROFIT ORGANIZATION THAT:**

1 **(I) PROVIDES SOCCER OPPORTUNITIES FOR CHILDREN UNDER**
2 **THE AGE OF 18 YEARS; AND**

3 **(II) IS RECOGNIZED BY THE UNITED STATES SOCCER**
4 **FEDERATION AS A MEMBER OF THE MARYLAND STATE YOUTH SOCCER**
5 **ASSOCIATION.**

6 **(B) (1) THERE IS A SOCCER OPPORTUNITIES PROGRAM IN THE**
7 **DEPARTMENT.**

8 **(2) THE PURPOSE OF THE SOCCER OPPORTUNITIES PROGRAM IS TO**
9 **INCREASE OPPORTUNITIES FOR MINORITY STUDENTS TO PARTICIPATE IN SOCCER**
10 **IN THEIR COMMUNITIES.**

11 **(C) THE STATE SUPERINTENDENT SHALL DEVELOP AND ADMINISTER THE**
12 **SOCCER OPPORTUNITIES PROGRAM.**

13 **(D) (1) A YOUTH SOCCER NONPROFIT ORGANIZATION MAY SUBMIT AN**
14 **APPLICATION TO THE DEPARTMENT TO RECEIVE A GRANT FOR A PROGRAM THAT IS:**

15 **(I) IN FURTHERANCE OF THE PURPOSE OF THE SOCCER**
16 **OPPORTUNITIES PROGRAM; AND**

17 **(II) 1. COMPOSED OF AT LEAST 50% MINORITY PLAYERS; OR**

18 **2. COMPOSED OF AT LEAST 50% PLAYERS WHO QUALIFY**
19 **TO RECEIVE FREE LUNCH UNDER THE NATIONAL SCHOOL LUNCH PROGRAM.**

20 **(2) AN APPLICATION SHALL INCLUDE:**

21 **(I) A DESCRIPTION OF THE SCOPE AND PURPOSE OF THE**
22 **PROGRAM;**

23 **(II) A BUSINESS PLAN THAT INCLUDES THE ESTIMATED TOTAL**
24 **COST OF THE PROGRAM; AND**

25 **(III) ANY OTHER INFORMATION REQUIRED BY THE**
26 **DEPARTMENT.**

27 **(E) IN AWARDING A GRANT UNDER THE SOCCER OPPORTUNITIES**
28 **PROGRAM, THE DEPARTMENT SHALL:**

1 **(1) REQUIRE THE GRANTEE TO PROVIDE MATCHING FUNDS FROM**
2 **ANY COMBINATION OF FEDERAL, COUNTY, MUNICIPAL, OR PRIVATE SOURCES; AND**

3 **(2) ENSURE THAT THE GRANT DOES NOT EXCEED 50% OF THE TOTAL**
4 **ANNUAL COST OF THE GRANTEE'S PROGRAM.**

5 **(F) THE STATE SUPERINTENDENT OR THE STATE SUPERINTENDENT'S**
6 **DESIGNEE SHALL:**

7 **(1) REVIEW GRANT APPLICATIONS SUBMITTED IN ACCORDANCE**
8 **WITH SUBSECTION (D) OF THIS SECTION; AND**

9 **(2) TO THE EXTENT FUNDS ARE AVAILABLE, PROVIDE GRANTS TO**
10 **YOUTH SOCCER NONPROFIT ORGANIZATIONS THAT MEET THE REQUIREMENTS FOR**
11 **A GRANT UNDER THIS SECTION.**

12 **(G) FOR FISCAL YEARS 2027, 2028, AND 2029, THE GOVERNOR SHALL**
13 **INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF AT LEAST \$100,000**
14 **FOR THE SOCCER OPPORTUNITIES PROGRAM.**

15 **(H) THE STATE SUPERINTENDENT SHALL ADOPT REGULATIONS TO CARRY**
16 **OUT THIS SECTION.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
18 1, 2025.
