4 FOR the purpose of authorizing a certain security guard agency to apply for the
5 appointment of special police officers in order to protect property owned or leased by
6 the security guard agency’s clients; and generally relating to special police officers.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 3–303.

16 (a) The following entities may apply for the appointment of special police officers
17 for the following purposes:

1 (1) a municipal corporation, county, or other governmental body of the
2 State, in order to protect property owned, leased, or regularly used by the governmental
3 body or any of its units;

4 (2) another state, or subdivision or unit of another state, that has an
5 interest in property located wholly or partly in this State, in order to protect the property;

6 (3) a college, university, or public school system in the State, in order to
7 protect its property or students; [or]

8 (4) a person that exists and functions for a legal business purpose, in order
9 to protect its business property; **OR**

10 **(5) A PERSON THAT HOLDS A VALID LICENSE AS A SECURITY GUARD**
11 **AGENCY UNDER TITLE 19, SUBTITLE 3 OF THE BUSINESS OCCUPATIONS AND**
12 **PROFESSIONS ARTICLE, IN ORDER TO PROTECT PROPERTY OWNED OR LEASED BY**
13 **ITS CLIENTS.**

14 (b) The applicant for a commission shall be at least 18 years old.

15 (c) (1) This subsection does not apply to an applicant for an initial commission
16 who, within 5 years prior to application, has:

17 (i) completed a basic training course for police officers approved by
18 the Secretary in consultation with the Maryland Police Training and Standards
19 Commission;

20 (ii) completed a basic training course for police officers similar to the
21 course described in item (i) of this paragraph in another state or for the federal government;

22 (iii) separated from a law enforcement agency in good standing; or

23 (iv) completed training approved by the Maryland Police Training
24 and Standards Commission for a special police officer at a State institution of higher
25 education.

26 (2) An applicant for an initial commission shall complete a training course
27 approved by the Secretary in consultation with the Maryland Police Training and
28 Standards Commission consisting of at least 80 hours of instruction, including instruction
29 on:

30 (i) criminal law;

31 (ii) constitutional procedural requirements relating to search,
32 seizure, and arrest; and

1 (iii) the appropriate use of force.

2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
3 October 1, 2025.
