BY adding to Article – Education Section 15-140 Annotated Code of Maryland (2022 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Education **15–140.** (A) **(1)** IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

17 18	(IV) A REFERRAL NETWORK OF ON-CAMPUS AND OFF-CAMPUS HEALTH CARE SERVICE PROVIDERS.
19 20 21	(D) ON OR BEFORE AUGUST 1, 2026, EACH PUBLIC SENIOR HIGHER EDUCATION INSTITUTION SHALL POST THE PLAN ADOPTED UNDER SUBSECTION (C) OF THIS SECTION ON THE INSTITUTION'S WEBSITE.
