5 6	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

9 10	(a) In this section, "unlawfully restrictive covenant" means any recorded covenant or restriction that restricts ownership based on race, religious belief, or national origin.
11 12	(c) (1) A person may execute and record a restrictive covenant modification to an unlawfully restrictive covenant in accordance with this section if the person:
13 14	(i) Holds an ownership interest in property that the person believes is subject to the unlawfully restrictive covenant; or
15 16	(ii) Is a nonprofit entity that is required to enforce within a defined residential neighborhood:
17 18 19	1. Covenants that limit architectural alterations, renovations, landscaping elements, or other modifications to residential lots in the neighborhood; and
20	2. The unlawfully restrictive covenant.
21 22 23	(2) (i) Subject to subparagraph (ii) of this paragraph, a county or municipality may execute and record a restrictive covenant modification to an unlawfully restrictive covenant in accordance with this section if:
24 25 26	1. The property that the county or municipality believes is subject to an unlawfully restrictive covenant is within the boundaries of the county or municipality; and

At least 30 days before executing and recording the restrictive covenant modification, the county or municipality provides written notice in accordance with subparagraph (iii) of this paragraph of the county's or municipality's intent to execute and record the restrictive covenant modification to all persons with an ownership interest in the property.
32 33 34	(ii) A person with an ownership interest in the property may decline to have the restrictive covenant modification executed and recorded by the county or municipality by notifying the county or municipality within 30 days after the date of notice.
