## A BILL ENTITLED

1 AN ACT concerning

2 **Public Libraries – State Library Resource Center – Funding**

3 FOR the purpose of altering the calculation of certain funding for the State Library  
4 Resource Center for certain fiscal years; and generally relating to the State Library  
5 Resource Center.

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
17 That the Laws of Maryland read as follows:

18 **Article – Education**

19 23–201.

20 (a) The Central Library of the Enoch Pratt Free Library System is the State  
21 Library Resource Center.

22 (b) The State Library Resource Center shall provide and expand access to  
23 specialized library materials and services that are necessary for coordinated, efficient, and  
24 economical library services in this State.

2 (c) (1) Subject to subsection (g) of this section, each year each participating  
3 regional resource center shall receive a minimum amount of funding for each resident of  
4 the area served, to be used for operating and capital expenses.

5 (2) The allocation shall be calculated as follows:

6 (i) [For each of fiscal years 2011 through 2015... \$6.75 per each  
7 resident of the area served;

8 (ii) For fiscal year 2016..... \$6.95 per each  
9 resident of the area served;

10 (iii) For fiscal year 2017..... \$7.15 per each  
11 resident of the area served;

12 (iv) For fiscal year 2018..... \$7.55 per each  
13 resident of the area served;

14 (v) For fiscal year 2019..... \$7.95 per each  
15 resident of the area served;

16 (vi) For fiscal year 2020..... \$8.35 per each  
17 resident of the area served;

18 [(vii)] (II) For fiscal year 2021..... \$8.55 per each  
19 resident of the area served;

20 [(viii)] (III) For fiscal year 2022.....\$8.75 per each  
21 resident of the area served;

22 [(ix)] (IV) For fiscal year 2023..... \$9.19 per each  
23 resident of the area served;

24 [(x)] (V) For fiscal year 2024..... \$9.39 per each  
25 resident of the area served;

26 [(xi)] (VI) For fiscal year 2025..... \$9.59 per each  
27 resident of the area served;

28 [(xii)] (VII) For fiscal year 2026.....\$9.79 per each  
29 resident of the area served; and

1 [(xiii)] (VIII) For fiscal year 2027 and each fiscal year  
2 thereafter..... \$9.99 per each  
3 resident of the area served.

4 (d) (1) Subject to subsection (g) of this section, each year the State Library  
5 Resource Center shall receive a minimum amount of funding for each State resident in the  
6 previous fiscal year, to be used for operating and capital expenses.

7 (2) The allocation shall be calculated as follows:

8 (i) [For each of fiscal years 2010 through  
9 2016.....\$1.67 per State resident;

10 (ii) For fiscal year 2017 .....\$1.69 per State resident;

11 (iii) For fiscal year 2018 .....\$1.73 per State resident;

12 (iv) For fiscal year 2019 .....\$1.77 per State resident;

13 (v) For fiscal year 2020 .....\$1.81 per State resident;

14 (vi) For fiscal year 2021 .....\$1.85 per State resident;

15 (vii) For fiscal year 2022 .....\$1.89 per State resident;

16 (viii) For fiscal year 2023 .....\$1.93 per State resident;

17 (ix) For fiscal year 2024 .....\$1.97 per State resident;

18 [and

19 (x) (II) For fiscal [year 2025 and each fiscal year thereafter]  
20 YEARS 2025 AND 2026 .....\$2.07 per State resident;

21 (III) FOR FISCAL YEAR 2027 .....\$2.15 PER STATE RESIDENT;

22 (IV) FOR FISCAL YEAR 2028 .....\$2.24 PER STATE RESIDENT;

23 (V) FOR FISCAL YEAR 2029 .....\$2.33 PER STATE RESIDENT;

24 (VI) FOR FISCAL YEAR 2030 .....\$2.42 PER STATE RESIDENT;

25 AND

26 (VII) FOR FISCAL YEAR 2031 AND EACH FISCAL YEAR  
27 THEREAFTER.....\$2.52 PER STATE RESIDENT.

1           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
2 1, 2025.
