ON RECEIPT OF A RESOLUTION FROM THE HOWARD COUNTY COUNCIL AND THE COMMISSION'S REPORT SUBMITTED UNDER § 28–1A–07(B) OF THIS SUBTITLE, THE MEMBERS OF THE HOWARD COUNTY DELEGATION TO THE GENERAL ASSEMBLY MAY INTRODUCE LEGISLATION TO ALTER THE SALARY OF MEMBERS OF THE HOWARD COUNTY BOARD OF EDUCATION.

## 7 SECTION 3. AND BE IT FURTHER ENACTED, That:

8 (1) The terms of the members of the Howard County Board of Education 9 elected from councilmanic districts in office on the effective date of this Act shall expire on 10 December 4, 2028; and

11 (2) The terms of the members of the Howard County Board of Education 12 elected by the voters of the county at large in office on the effective date of this Act shall 13 expire on December 7, 2026.

SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July1, 2025.
