#### **Opioid Restitution Fund – Interactive Dashboard**

3 FOR the purpose of requiring the Maryland Office of Overdose Response, in collaboration with the Maryland Department of Health, to develop and maintain an interactive 4  $\mathbf{5}$ dashboard on Opioid Restitution Fund spending to share prescription opioid-related 6 settlement information with the public; requiring the dashboard to include links to 7 the State, county, or municipal websites that provide access to additional information on the use of opioid-related settlement funds; requiring counties and 8 9 municipalities receiving settlement funding to provide certain information to the 10 Department to include on the dashboard in a certain manner; requiring that the 11 dashboard be developed and maintained using funds from the Opioid Restitution 12 Fund appropriated through the State budget; and generally relating to an interactive 13dashboard on Opioid Restitution Fund spending.

4 **(**A**)** THE MARYLAND OFFICE OF **OVERDOSE RESPONSE**, IN COLLABORATION WITH THE DEPARTMENT, SHALL DEVELOP AND MAINTAIN AN  $\mathbf{5}$ 6 INTERACTIVE DASHBOARD ON OPIOID RESTITUTION FUND SPENDING FOR THE 7 PRESCRIPTION **OPIOID-RELATED** PURPOSE OF SHARING SETTLEMENT INFORMATION WITH THE PUBLIC. 8

9 (B) THE DASHBOARD DEVELOPED AND MAINTAINED UNDER SUBSECTION 10 (A) OF THIS SECTION SHALL INCLUDE, DISAGGREGATED BY STATE, COUNTY, AND 11 MUNICIPALITY:

12 (1) PAYMENT SCHEDULE INFORMATION ON ESTIMATED PAYMENTS 13 TO THE STATE, COUNTY, OR MUNICIPALITY FROM OPIOID SETTLEMENTS;

- 14 (2) PAST SPENDING OF SETTLEMENT FUNDS;
- 15 (3) SPENDING PLANS AND PRIORITIES; AND

16 (4) A DETAILED DESCRIPTION OF ANY INITIATIVE FUNDED WITH 17 SETTLEMENT FUNDS, INCLUDING PERFORMANCE MEASURES IF APPLICABLE.

18 (C) THE IF THERE IS A STATE, COUNTY, OR MUNICIPAL WEBSITE THAT 19 PROVIDES ACCESS TO ADDITIONAL INFORMATION ON THE USE OF OPIOID-RELATED 20 SETTLEMENT FUNDS BY THE STATE, COUNTY, OR MUNICIPALITY, THE DASHBOARD 21 SHALL INCLUDE INFORMATION ON PUBLIC HEARINGS CONDUCTED IN THE STATE, 22 COUNTY, OR MUNICIPALITY REGARDING THE USE OF SETTLEMENT FUNDS FROM THE 23 OPIOID RESTITUTION FUND A LINK TO THE STATE, COUNTY, OR MUNICIPAL 24 WEBSITE.

# 25(D)(1)THIS SUBSECTION DOES NOT APPLY TO A COUNTY OR26MUNICIPALITY THAT:

- 27(I)COMPLIESWITHREPORTINGREQUIREMENTS28ESTABLISHED IN AN OPIOID-RELATED SETTLEMENT; AND
- 29(II)SHARES THE DATA IN THE REPORTS REQUIRED UNDER AN30OPIOID-RELATED SETTLEMENT WITH THE APPROPRIATE STATE ENTITY.

1 (2) A COUNTY OR MUNICIPALITY RECEIVING SETTLEMENT FUNDS 2 SHALL PROVIDE TO THE DEPARTMENT THE NECESSARY FINANCIAL INFORMATION 3 RELATED TO SETTLEMENT FUNDING TO INCLUDE AS INFORMATION ON THE 4 DASHBOARD.

5 (2) (3) INFORMATION REQUIRED TO BE PROVIDED UNDER 6 PARAGRAPH (1) (2) OF THIS SUBSECTION SHALL BE IN COMPLIANCE WITH THE 7 TERMS OF ANY OPIOID-RELATED SETTLEMENT AGREEMENT.

8 (3) (4) THE DEPARTMENT SHALL UPLOAD OPIOID-RELATED 9 SETTLEMENT INFORMATION SUBMITTED TO THE DEPARTMENT BY A COUNTY OR 10 MUNICIPALITY IN COMPLIANCE WITH THE TERMS OF AN OPIOID-RELATED 11 SETTLEMENT.

12(5)THE DEPARTMENT SHALL ESTABLISH AN ONLINE PORTAL WITH13INSTRUCTIONS FOR A COUNTY OR MUNICIPALITY TO REPORT OR UPLOAD REQUIRED14INFORMATION TO THE DEPARTMENT FOR USE IN THE DASHBOARD.

15 (E) TO THE EXTENT PRACTICABLE, THE DASHBOARD SHALL USE EXISTING 16 PLATFORMS THAT PROVIDE DATA ON OPIOID USE AND OVERDOSES IN THE STATE.

17 (F) THE DASHBOARD SHALL BE DEVELOPED AND MAINTAINED USING 18 FUNDS FROM THE OPIOID RESTITUTION FUND AS APPROPRIATED THROUGH THE 19 STATE BUDGET.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 21 October 1, 2025.
