## A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Cosmetologists – Licensing – Eyelash Extensions**

3 FOR the purpose of authorizing the State Board of Cosmetologists to issue a limited license  
4 to provide eyelash extension services; altering the definition of “provide esthetic  
5 services” to include providing eyelash extension services; and generally relating to  
6 licensing and the State Board of Cosmetologists.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
24 That the Laws of Maryland read as follows:

25 **Article – Business Occupations and Professions**

2 (a) In this title the following words have the meanings indicated.

3 (i) (1) “License” means, unless the context requires otherwise, a license issued  
4 by the Board.

5 (2) “License” includes, unless the context requires otherwise, each of the  
6 following licenses:

7 (i) a license to practice cosmetology;

8 (ii) a license to practice as a senior cosmetologist;

9 (iii) a limited license to provide esthetic services;

10 (iv) a limited license to provide hair services;

11 (v) a limited license to provide hair services – blow drying; [and]

12 (vi) a limited license to provide nail technician services; AND

13 (VII) A LIMITED LICENSE TO PROVIDE EYELASH EXTENSION  
14 SERVICES.

15 (l) (1) “Limited license” means a license issued by the Board to practice  
16 cosmetology as limited in § 5–301 of this title.

17 (2) “Limited license” includes, unless the context requires otherwise, each  
18 of the following licenses:

19 (i) a limited license to provide esthetic services;

20 (ii) a limited license to provide hair services;

21 (iii) a limited license to provide hair services – blow drying; [and]

22 (iv) a limited license to provide nail technician services; AND

23 (V) A LIMITED LICENSE TO PROVIDE EYELASH EXTENSION  
24 SERVICES.

25 (n) (1) “Practice cosmetology” means to engage in any of the following for  
26 compensation:

27 (i) providing hair services;

1 (ii) arching or dyeing eyebrows;

2 (iii) dyeing eyelashes;

3 (iv) providing esthetic services; [or]

4 (v) providing nail technician services; **OR**

5 **(VI) PROVIDING EYELASH EXTENSION SERVICES.**

6 (2) The practice of cosmetology does not include:

7 (i) the mere sale, fitting, or styling of wigs or hairpieces;

8 (ii) the mere shampooing of hair; or

9 (iii) a service that results in tension on hair strands or roots by  
10 twisting, wrapping, weaving, extending, locking, or braiding by hand or mechanical device,  
11 provided that the service does not include the application of dyes, reactive chemicals, or  
12 other preparations to alter the color of the hair or to straighten, curl, or alter the structure  
13 of the hair.

14 (o) (1) "Provide esthetic services" means to provide to an individual, for  
15 compensation, the service of:

16 (i) cleansing, exercising, exfoliating, massaging, cosmetic  
17 microneedling, stimulating, toning, or performing any other similar procedure on the skin  
18 or scalp by electrical, mechanical, or any other means;

19 (ii) applying to the face, body, or scalp an alcohol, cream, lotion,  
20 astringent, or cosmetic preparation; [or]

21 (iii) removing superfluous hair by the use of electrical, mechanical,  
22 or any means other than by the use of a laser light-based device; **OR**

23 **(IV) PROVIDING EYELASH EXTENSION SERVICES.**

24 (2) "Provide esthetic services" includes:

25 (i) applying eyelash extensions;

26 (ii) performing superficial exfoliation treatments of the epidermis  
27 using professional and other commercially available products or devices;

1 (iii) performing treatments for the relaxation, hydration, contouring,  
2 and beautification of the face, skin, body, eyelashes, or eyebrows; and

3 (iv) performing nonablative skin rejuvenation.

4 (3) "Provide esthetic services" does not include:

5 (i) the diagnosis of illness, disease, or injury; or

6 (ii) performing ablation of the dermis or hypodermis.

7 **(P) "PROVIDE EYELASH EXTENSION SERVICES" MEANS TO PROVIDE TO AN**  
8 **INDIVIDUAL, FOR COMPENSATION, THE SERVICE OF:**

9 **(1) CLEANING THE EYE AREA;**

10 **(2) APPLYING:**

11 **(I) EYELASH PRIMERS AND ADHESIVES;**

12 **(II) EYELASH EXTENSIONS; AND**

13 **(III) SEALANT; OR**

14 **(3) DRYING THE EYE AREA FOR EYELASH EXTENSIONS.**

15 **[(p)] (Q)** "Provide hair services" means to provide to an individual for  
16 compensation the service of beautifying, cleaning, or embellishing the hair of the individual  
17 by:

18 (1) arranging the hair;

19 (2) bleaching the hair;

20 (3) cleansing the hair;

21 (4) coloring the hair;

22 (5) curling the hair;

23 (6) cutting the hair;

24 (7) dressing the hair;

25 (8) singeing the hair;

1 (9) permanent waving the hair;

2 (10) waving the hair; or

3 (11) performing any other similar procedure intended to beautify, clean, or  
4 embellish the hair.

5 **[(q)] (R)** “Provide hair services – blow drying” means to provide to an individual  
6 for compensation the service of beautifying, cleaning, or arranging the hair of the individual  
7 by:

8 (1) arranging the hair;

9 (2) cleansing the hair;

10 (3) curling the hair;

11 (4) dressing the hair;

12 (5) blow drying the hair;

13 (6) singeing the hair; or

14 (7) performing any other similar procedure intended to beautify, clean, or  
15 arrange the hair.

16 **[(r)] (S)** “Provide nail technician services” means to provide to an individual, for  
17 compensation, the service of:

18 (1) manicuring or pedicuring the individual’s nails;

19 (2) applying artificial nail enhancement products; or

20 (3) maintaining artificial nail enhancement products.

21 5–205.

22 (b) (1) The Board shall adopt regulations that establish detailed curriculum  
23 standards for use by the State Board of Education or the Maryland Higher Education  
24 Commission in approving applications for instruction in the practice of cosmetology, the  
25 provision of esthetic services, **THE PROVISION OF EYELASH EXTENSION SERVICES**, the  
26 provision of hair services, and the provision of nail technician services at public schools or  
27 private career schools.

28 (2) The curriculum standards established under paragraph (1) of this  
29 subsection shall:

- 1 (i) incorporate modern methods and practices for:
- 2 1. practicing cosmetology;
- 3 2. providing esthetic services;
- 4 **3. PROVIDING EYELASH EXTENSION SERVICES;**
- 5 ~~[3.]~~ 4. providing hair services;
- 6 ~~[4.]~~ **5.** providing hair services – blow drying; and
- 7 ~~[5.]~~ **6.** providing nail technician services;
- 8 (ii) include a reference to each topic and the emphasis of each topic
- 9 required of a comprehensive curriculum in the appropriate licensing area; and
- 10 (iii) be reviewed and updated periodically as determined by the
- 11 Board.

12 (c) (1) ~~[Beginning October 1, 2018, the]~~ **THE** Board shall require a licensee

13 renewing a license to complete at least six credit hours of continuing education approved

14 by the Board.

15 (2) The Board shall adopt regulations that set standards for continuing

16 education courses that, at a minimum, require:

- 17 (i) two hours of training in health, safety, and welfare subjects; and
- 18 (ii) four hours of training in general elective courses.

19 5–301.

20 (a) Except as otherwise provided in this title, an individual shall be licensed by

21 the Board to practice cosmetology before the individual may practice cosmetology in the

22 State.

23 (b) If an individual holds the appropriate limited license, the individual may

24 practice cosmetology in a manner limited to:

- 25 (1) providing esthetic services;
- 26 **(2) PROVIDING EYELASH EXTENSION SERVICES;**
- 27 ~~[(2)]~~ **(3)** providing hair services;

1           ~~[(3)]~~ (4)       providing hair services – blow drying; or

2           ~~[(4)]~~ (5)       providing nail technician services.

3           (c)       Subsection (a) of this section does not apply to:

4               (1)       a student while the student practices cosmetology in accordance with §  
5 5–302 or § 5–303 of this subtitle; or

6               (2)       a registered apprentice.

7 5–305.

8           (a)       To qualify for a limited license to practice cosmetology, an applicant shall be  
9 an individual who meets the requirements of this section.

10          (b)       An applicant for a limited license to provide esthetic services shall:

11               (1)       be at least 17 years old;

12               (2)       have completed successfully a 9th grade education or the equivalent;

13 and

14               (3)       have received training by:

15                   (i)       serving as a registered apprentice for at least 6 months as  
16 provided under §§ 5–404 and 5–405 of this title; or

17                   (ii)       successfully completing at least 600 hours of instruction in  
18 providing esthetic services in a cosmetology school approved by the State Department of  
19 Education or the Maryland Higher Education Commission in consultation with the Board.

20          **(C) AN APPLICANT FOR A LIMITED LICENSE TO PROVIDE EYELASH  
21 EXTENSION SERVICES SHALL:**

22               **(1) BE AT LEAST 17 YEARS OLD;**

23               **(2) HAVE COMPLETED SUCCESSFULLY A 9TH GRADE EDUCATION OR  
24 THE EQUIVALENT; AND**

25               **(3) (I) HAVE RECEIVED TRAINING BY:**

26                   **1. SERVING AS A REGISTERED APPRENTICE FOR AT  
27 LEAST 3 MONTHS AS PROVIDED UNDER §§ 5–404 AND 5–405 OF THIS TITLE; OR**

1                                   **2. SUCCESSFULLY COMPLETING AT LEAST 100 HOURS**  
2 **OF INSTRUCTION IN PROVIDING EYELASH EXTENSION SERVICES IN A COSMETOLOGY**  
3 **SCHOOL APPROVED BY THE STATE DEPARTMENT OF EDUCATION OR THE**  
4 **MARYLAND HIGHER EDUCATION COMMISSION IN CONSULTATION WITH THE**  
5 **BOARD; OR**

6                                   **(II) PASS A PRACTICAL AND WRITTEN EXAMINATION**  
7 **ADMINISTERED BY THE BOARD.**

8           **[(c)] (D)**       An applicant for a limited license to provide hair services shall:

9                           (1)    be at least 17 years old;

10                          (2)    have completed successfully a 9th grade education or the equivalent;

11 and

12                          (3)    have received training by:

13                           (i)    serving as a registered apprentice for at least 15 months as  
14 provided under §§ 5–404 and 5–405 of this title; or

15                           (ii)   successfully completing at least 1,200 hours of instruction  
16 providing hair services in a cosmetology school approved by the State Department of  
17 Education or the Maryland Higher Education Commission in consultation with the Board.

18           **[(d)] (E)**       An applicant for a limited license to provide hair services – blow drying  
19 shall:

20                           (1)    be at least 17 years old;

21                          (2)    have completed successfully a 9th grade education or the equivalent;

22 and

23                          (3)    have received training by successfully completing at least 350 hours of  
24 instruction providing hair services – blow drying in a cosmetology school approved by the  
25 State Department of Education or the Maryland Higher Education Commission in  
26 consultation with the Board.

27           **[(e)] (F)**       An applicant for a limited license to provide nail technician services  
28 shall:

29                           (1)    be at least 17 years old;

30                          (2)    have successfully completed a 9th grade education or the equivalent;

31 and



1 (3) have received training by:

2 (i) serving as a registered apprentice for at least 3 months as  
3 provided under §§ 5–404 and 5–405 of this title; or

4 (ii) successfully completing at least 250 hours of instruction in  
5 providing nail technician services in a cosmetology school approved by the State  
6 Department of Education or the Maryland Higher Education Commission in consultation  
7 with the Board.

8 **[(f)] (G)** If an applicant is licensed to practice as an esthetician, **EYELASH**  
9 **EXTENSION TECHNICIAN**, hairstylist, hairstylist – blow drying technician, or nail  
10 technician in another state or foreign country, the applicant meets the training  
11 requirements of this section if the applicant has held a limited license in the other state or  
12 foreign country and has actively practiced in the other state or foreign country for a period  
13 of 6 months.

14 **[(g)] (H)** An applicant for a limited license shall pass an examination given by  
15 the Board under this subtitle.

16 5–310.

17 (a) Subject to subsections (b), (c), (d), **[and] (e), AND (F)** of this section and while  
18 a license to practice cosmetology is in effect, it authorizes the licensee to practice  
19 cosmetology.

20 (b) While a limited license to provide esthetic services is in effect, it authorizes  
21 the licensee to provide only esthetic services.

22 **(C) WHILE A LIMITED LICENSE TO PROVIDE EYELASH EXTENSION SERVICES**  
23 **IS IN EFFECT, IT AUTHORIZES THE LICENSEE TO PROVIDE ONLY EYELASH**  
24 **EXTENSION SERVICES.**

25 **[(c)] (D)** While a limited license to provide hair services is in effect, the license  
26 authorizes the licensee to provide only hair services.

27 **[(d)] (E)** While a limited license to provide hair services – blow drying is in effect,  
28 the license authorizes the licensee to provide only hair services – blow drying.

29 **[(e)] (F)** While a limited license to provide nail technician services is in effect, it  
30 authorizes the licensee to provide only nail technician services.

31 5–404.

32 (a) While registration as an apprentice is in effect, the registration authorizes the  
33 individual to learn to practice cosmetology or any limited practice of cosmetology:

1 (1) in a:

2 (i) beauty salon that holds a beauty salon permit; or

3 (ii) barbershop that holds a barbershop permit; and

4 (2) under the supervision of:

5 (i) if learning to practice cosmetology, a licensed senior  
6 cosmetologist;

7 (ii) if learning to provide esthetic services, a licensed senior  
8 cosmetologist or a licensed esthetician with 2 years' experience;

9 **(III) IF LEARNING TO PROVIDE EYELASH EXTENSION SERVICES:**

10 **1. BEGINNING JANUARY 1, 2027, A LICENSED SENIOR**  
11 **COSMETOLOGIST WHO HAS COMPLETED CONTINUING EDUCATION REQUIREMENTS**  
12 **IN PROVIDING EYELASH EXTENSION SERVICES; OR**

13 **2. A LICENSED EYELASH EXTENSION TECHNICIAN WITH**  
14 **2 YEARS' EXPERIENCE;**

15 **[(iii)] (IV)** if learning to provide hair services, a licensed senior  
16 cosmetologist or a licensed hairstylist with 2 years' experience; and

17 **[(iv)] (V)** if learning to provide nail technician services, a licensed  
18 senior cosmetologist or a licensed nail technician with 2 years' experience.

19 (b) A licensed senior cosmetologist may directly train and supervise not more  
20 than two apprentices learning to practice cosmetology or any limited practice of  
21 cosmetology specified in subsection (a)(2) of this section.

22 (c) An individual with one of the limited licenses specified in subsection (a)(2) of  
23 this section who has at least 2 years of experience in that limited practice of cosmetology  
24 may directly train and supervise not more than two apprentices learning the same limited  
25 practice of cosmetology.

26 5-501.

27 (a) A person shall hold a beauty salon permit issued by the Board before the  
28 person may operate a beauty salon in the State.

29 (b) A beauty salon may operate as a limited practice beauty salon by offering  
30 cosmetology services limited to:

1 (1) providing esthetic services;

2 **(2) PROVIDING EYELASH EXTENSION SERVICES;**

3 ~~[(2)]~~ **(3)** providing hair services;

4 ~~[(3)]~~ **(4)** providing hair services – blow drying; or

5 ~~[(4)]~~ **(5)** providing nail technician services.

6 (c) A separate beauty salon permit is required for each beauty salon that a person  
7 operates.

8 5–605.

9 (a) Except as provided in §§ 5–302 and 5–303 of this title and subsection (b) of  
10 this section, a person may not practice cosmetology, provide esthetic services, **PROVIDE**  
11 **EYELASH EXTENSION SERVICES**, provide hair services, provide hair services – blow  
12 drying, or provide nail technician services in any place other than:

13 (1) a beauty salon that holds a beauty salon permit; or

14 (2) a barbershop that holds a barbershop permit issued under Title 4 of this  
15 article.

16 (b) (1) A licensed cosmetologist, esthetician, **EYELASH EXTENSION**  
17 **TECHNICIAN**, hairstylist, hairstylist – blow dry technician, or nail technician may practice  
18 cosmetology and provide services in:

19 (i) a facility in which beautification–oriented medical services,  
20 authorized by the Maryland Department of Health, are provided;

21 (ii) the residence of an individual confined to the residence by reason  
22 of a physical or mental infirmity;

23 (iii) an assisted living facility as defined in § 19–1801 of the Health –  
24 General Article;

25 (iv) a hospice facility defined in § 19–901(c) of the Health – General  
26 Article;

27 (v) a nursing home as defined in § 19–1401(e) of the Health –  
28 General Article; or

1 (vi) a hospital as defined in § 19–301 of the Health – General Article  
2 or a similar institution.

3 (2) To practice in any of the locations specified in this subsection:

4 (i) the licensed cosmetologist, esthetician, **EYELASH EXTENSION**  
5 **TECHNICIAN**, hairstylist, hairstylist – blow dry technician, or nail technician shall be  
6 sponsored by a beauty salon in which the cosmetologist, esthetician, hairstylist, hairstylist  
7 – blow dry technician, or nail technician is authorized to practice;

8 (ii) the patron to whom the services are rendered shall be a customer  
9 of the beauty salon; and

10 (iii) the services shall be rendered by appointment through the  
11 beauty salon.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
13 October 1, 2025.
