7 8	(i) the employee may be eligible for the federal earned income tax credit under § 32 of the Internal Revenue Code; and
9 10	(ii) the employee may be eligible for the earned income tax credit under $\S 10-704$ of this title.
11	(2) An employer may provide the notice required under this subsection to:
