## A BILL ENTITLED

1 AN ACT concerning

2 **Nursing Homes – Direct Care Wages and Benefits and Cost Reports**  
3 **(Nursing Home Care Crisis Transparency Act)**

4 FOR the purpose of requiring a nursing home to expend at least a certain percentage of its  
5 total nursing and residential care revenue for direct care wages and benefits;  
6 requiring nursing homes to annually submit a certain cost report to the Maryland  
7 Department of Health; and generally relating to nursing homes.

8 BY adding to

9 Article – Health – General

10 Section 16–209 and 16–210

11 Annotated Code of Maryland

12 (2023 Replacement Volume and 2024 Supplement)

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
14 That the Laws of Maryland read as follows:

15 **Article – Health – General**

16 **16–209.**

17 **(A) IN THIS SECTION, “DIRECT CARE WAGES AND BENEFITS” MEANS THE**  
18 **DIRECT CARE WORKFORCE WAGES AND BENEFITS FOR NURSING, DIETARY,**  
19 **RESTORATIVE THERAPY, AND SOCIAL WORKER STAFF.**

20 **(B) A NURSING HOME SHALL EXPEND AT LEAST 75% OF ITS TOTAL NURSING**  
21 **AND RESIDENTIAL CARE REVENUE FOR DIRECT CARE WAGES AND BENEFITS.**

1           **(A) ON OR BEFORE SEPTEMBER 1 EACH YEAR, BEGINNING IN 2026, EACH**  
2 **NURSING HOME SHALL SUBMIT TO THE DEPARTMENT A COST REPORT IN THE FORM**  
3 **AND MANNER REQUIRED BY THE DEPARTMENT.**

4           **(B) THE COST REPORT REQUIRED UNDER SUBSECTION (A) OF THIS SECTION**  
5 **SHALL:**

6           **(1) INCLUDE:**

7                   **(I) DOCUMENTATION OF WAGE DISBURSEMENT; AND**

8                   **(II) ANY OTHER INFORMATION THE DEPARTMENT DETERMINES**  
9 **IS APPROPRIATE; AND**

10           **(2) BE SIGNED BY AN AUTHORIZED REPRESENTATIVE OF THE**  
11 **NURSING HOME UNDER PENALTY OF PERJURY.**

12           **(C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE**  
13 **DEPARTMENT MAY TAKE APPROPRIATE ENFORCEMENT ACTION AGAINST A**  
14 **NURSING HOME IF THE NURSING HOME:**

15                   **(I) FAILS TO SUBMIT A COST REPORT AS REQUIRED;**

16                   **(II) SUBMITS AN INACCURATE, INCOMPLETE, OR INVALID COST**  
17 **REPORT; OR**

18                   **(III) FAILS TO PAY THE WAGES IN THE AMOUNT REQUIRED.**

19           **(2) THE ENFORCEMENT ACTION THAT THE DEPARTMENT MAY TAKE**  
20 **UNDER PARAGRAPH (1) OF THIS SUBSECTION INCLUDES:**

21                   **(I) RECOUPMENT BY THE DEPARTMENT OF FUNDING**  
22 **RESULTING FROM THE REIMBURSEMENT RATE INCREASE PROVIDED FOR UNDER §**  
23 **16-201.4(B) OF THIS SUBTITLE;**

24                   **(II) IMPOSITION OF A CORRECTIVE PLAN; OR**

25                   **(III) SUSPENSION OR TERMINATION FROM THE PROGRAM.**

26           **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June**  
27 **1, 2025.**
