
 2 (a) (1) Except as otherwise specifically provided by law or by regulation of the 3 Treasurer, the Treasurer shall credit to the General Fund any interest on or other income 4 from State money that the Treasurer invests.
- 5 (2) (i) 1. This subparagraph does not apply in fiscal years 2024 6 through 2028.
- Notwithstanding any other provision of law, and unless inconsistent with a federal law, grant agreement, or other federal requirement or with the terms of a gift or settlement agreement, net interest on all State money allocated by the State Treasurer under this section to special funds or accounts, and otherwise entitled to receive interest earnings, as accounted for by the Comptroller, shall accrue to the General Fund of the State.

- 18 (a) In this section, "Account" means the Catastrophic Event Account.
- 19 (b) Subject to the provisions of this section, the Account is established to enable 20 the State or a local government to respond without undue delay to:
- 21 (1) a natural disaster or other catastrophic situation[, or];
- (2) federal employee financial hardship from a full or partial federal government shutdown due to a lapse in federal appropriations that cannot be taken care of within the resources of existing appropriations; **OR**
- 25 (3) FORMER FEDERAL EMPLOYEE FINANCIAL HARDSHIP FROM THE 26 CLOSURE, RELOCATION, OR MASS LAYOFF OF A UNIT OF THE FEDERAL 27 GOVERNMENT, OR OTHER SIMILAR CIRCUMSTANCES.
- 28 (c) The Governor may provide an appropriation in the budget bill to the Account.
- 29 (d) (1) Subject to paragraph (2) of this subsection, after a 15-day review and 30 comment period by the Legislative Policy Committee, the Governor may transfer funds by 31 budget amendment from the Account to the expenditure accounts of the appropriate unit 32 of State government or unit of local government.

- 1 If the federal government is in a full or partial shutdown due to a lapse (2)2 in appropriations, after a 2-day review and comment period by the Legislative Policy 3 Committee, the Governor may transfer funds by budget amendment from the Account to 4 the Federal Government [Shutdown] Employee Assistance Loan Fund established under § 7–327 of this subtitle. 5 6 (e) Funds appropriated to the Catastrophic Event Account: 7 may not be used to offset operating deficiencies in regular programs of (1)8 State government; but 9 may be expended to assist a unit of State government or unit of local 10 government in funding costs in connection with: 11 a natural disaster[,]; (I)12 (II)a catastrophic situation[, or]; 13 a full or partial federal government shutdown due to a lapse in 14 appropriations; OR 15 (IV) A CLOSURE, RELOCATION, OR MASS LAYOFF OF A UNIT OF 16 THE FEDERAL GOVERNMENT. 17 The Account is a continuing, nonlapsing fund which is not subject to § (1) 18 7–302 of this subtitle. 19 (2)The Treasurer shall separately hold, and the Comptroller shall account 20 for, the Account. 21The Account shall be invested and reinvested in the same manner as (3)22 other State funds. 23 **(4)** Any investment earnings shall be subject to § 7–311(d) of this subtitle.
