BY adding to Article – Environment Section 1–1001 and 1–1002 to be under the new subtitle "Subtitle 10. Ecological Restoration" Annotated Code of Maryland (2013 Replacement Volume and 2024 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Environment SUBTITLE 10. ECOLOGICAL RESTORATION.
