- 1 (D) (1) THERE IS A WILDLIFE DAMAGE PREVENTION AND 2 REIMBURSEMENT FUND IN THE DEPARTMENT.

- 4 AGENT OF THE UNIVERSITY OF MARYLAND COOPERATIVE EXTENSION SERVICE;
