### A BILL ENTITLED

### 1 AN ACT concerning

## Wicomico County - Alcoholic Beverages - Temporary To-Go Event Permit and Class C Per Diem Municipal To-Go Beer, Wine, and Liquor License

- 4 FOR the purpose of establishing a temporary to-go event permit in Wicomico County;  $\mathbf{5}$ authorizing the Board of License Commissioners for Wicomico County to issue a 6 temporary to-go event permit to a holder of a Class B beer, wine, and liquor license 7 under certain circumstances; establishing a Class C per diem municipal to-go beer, 8 wine, and liquor license in the county; authorizing the Board to issue a Class C per 9 diem municipal to-go beer, wine, and liquor license to a municipality in the county; requiring the Board to adopt certain regulations; and generally relating to alcoholic 10 11 beverages in Wicomico County.
