## A BILL ENTITLED

1 AN ACT concerning

2 **Wicomico County – Alcoholic Beverages Licenses – Athletic and Event Facility**  
3 **License**

4 FOR the purpose of authorizing the Board of License Commissioners for Wicomico County  
5 to issue a Class B (athletic and event facility) beer, wine, and liquor license to a  
6 certain facility under certain circumstances; authorizing the license holder to sell  
7 beer, wine, and liquor for on–premises consumption under certain circumstances;  
8 prohibiting the Board from issuing the license before certain regulations take effect;  
9 and generally relating to alcoholic beverages licenses in Wicomico County.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
27 That Section(s) 32–1001 through 32–1001.3 of Article – Alcoholic Beverages and Cannabis

3 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
4 as follows:

5 **Article – Alcoholic Beverages and Cannabis**

6 32–102.

7 This title applies only in Wicomico County.

8 **32–1001.**

9 **(A) IN THIS SECTION, “FACILITY” MEANS:**

10 **(1) AN ATHLETIC FACILITY;**

11 **(2) AN AUDITORIUM;**

12 **(3) A BANQUET HALL; OR**

13 **(4) A CONFERENCE CENTER.**

14 **(B) THERE IS A CLASS B (ATHLETIC AND EVENT FACILITY) BEER, WINE, AND**  
15 **LIQUOR LICENSE.**

16 **(C) SUBJECT TO SUBSECTION (E) OF THIS SECTION, THE BOARD MAY ISSUE**  
17 **THE LICENSE FOR USE AT A FACILITY THAT HAS:**

18 **(1) A KITCHEN FOR THE PREPARATION AND MANAGEMENT OF FOOD**  
19 **FOR SERVICE IN CONJUNCTION WITH THE SALE OF ALCOHOL; AND**

20 **(2) A CAPACITY OF AT LEAST 500 PEOPLE.**

21 **(D) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,**  
22 **AND LIQUOR, FROM ONE OR MORE OUTLETS LOCATED WITHIN THE FACILITY, FOR**  
23 **ON-PREMISES CONSUMPTION.**

24 **(E) THE BOARD SHALL ADOPT REGULATIONS:**

25 **(1) PROHIBITING THE CONSUMPTION OF ALCOHOL BY SPECTATORS**  
26 **AND OTHER PARTICIPANTS IN YOUTH EVENTS, INCLUDING YOUTH ATHLETIC**  
27 **EVENTS; AND**

1           **(2) ESTABLISHING REQUIREMENTS FOR:**

2                   **(I) THE DISPENSING OF ALCOHOLIC BEVERAGES;**

3                   **(II) THE NUMBER OF OUTLETS AUTHORIZED TO DISPENSE**  
4 **ALCOHOLIC BEVERAGES WITHIN A FACILITY;**

5                   **(III) THE MINIMUM CAPITAL INVESTMENT IN THE LICENSED**  
6 **PREMISES;**

7                   **(IV) THE HOURS AND DAYS OF SALE; AND**

8                   **(V) THE ANNUAL LICENSE FEE.**

9           SECTION 3. AND BE IT FURTHER ENACTED, That the Board of License  
10 Commissioners for Wicomico County may not issue a Class B (athletic and event facility)  
11 beer, wine, and liquor license under § 32–1001 of the Alcoholic Beverages and Cannabis  
12 Article, as enacted by Section 2 of this Act, until the regulations the Board adopts under §  
13 32–1001(e) of the Alcoholic Beverages and Cannabis Article, as enacted by Section 2 of this  
14 Act, take effect.

15           SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
16 1, 2025.
