- 2 (A) THERE IS A VENUE BEER, WINE, AND LIQUOR LICENSE.
- 3 (B) THE BOARD MAY ISSUE THE LICENSE TO A NONPROFIT OR FOR-PROFIT
- 4 RETAIL BUSINESS THAT HOSTS WEDDINGS, BANQUETS, PARTIES, MEETINGS, AND
- 5 SIMILAR EVENTS, WHETHER PRIVATE OR OPEN TO THE PUBLIC, AT A VENUE THAT:
- 6 (1) IS AT LEAST 2,000 SQUARE FEET IN SIZE;
- 7 (2) CAN ACCOMMODATE AT LEAST 100 INDIVIDUALS FOR A SINGLE
- 8 EVENT, WHETHER INSIDE THE VENUE OR OUTSIDE ON THE VENUE'S PREMISES; AND

- 10 (C) (1) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL OR
- 11 SERVE BEER, WINE, AND LIQUOR AT RETAIL, BY THE DRINK OR BY THE BOTTLE, FOR
- 12 ON-PREMISES CONSUMPTION:
- 13 (I) DURING AN EVENT HOSTED BY THE LICENSE HOLDER AT

- 15 (II) ONLY IF FOOD IS ALSO PROVIDED DURING THE EVENT.

- 22 (F) THE ANNUAL FEE FOR THE LICENSE IS \$1,500.
