21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
22 That the Laws of Maryland read as follows:

23 **Chapter 936 of the Acts of 2024**

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That:

3 (a) There is a Task Force on the Creation of a Division of Returning Citizens and
4 Expanded Reentry Services.

5 (i) On or before [December 31, 2025] **OCTOBER 31, 2026**, the Task Force shall,
6 in accordance with § 2–1257 of the State Government Article, submit a report to the
7 General Assembly of its findings and recommendations.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
9 1, 2024. It shall remain effective for a period of [2] **3** years and 1 month and, at the end of
10 June 30, [2026] **2027**, this Act, with no further action required by the General Assembly,
11 shall be abrogated and of no further force and effect.

12 Chapter 937 of the Acts of 2024

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That:

15 (a) There is a Task Force on the Creation of a Division of Returning Citizens and
16 Expanded Reentry Services.

17 (i) On or before [December 31, 2025] **OCTOBER 31, 2026**, the Task Force shall,
18 in accordance with § 2–1257 of the State Government Article, submit a report to the
