## A BILL ENTITLED

1 AN ACT concerning

2 **Cyber Maryland Program – Revisions**

3 FOR the purpose of transferring the Cyber Maryland Program from the Maryland  
4 Technology Development Corporation to the Maryland Department of Labor;  
5 altering the duties of the Program; requiring the Program to award certain  
6 competitive grants and contracts; altering the purposes for which the Cyber  
7 Maryland Fund may be used; altering certain funding requirements related to the  
8 Program; requiring that unused balances from certain programs and funds be  
9 transferred to the Program at the close of the fiscal year; altering the membership of  
10 the Cyber Maryland Board; and generally relating to the Cyber Maryland Program.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
2 That Section(s) 10–491 and the part “Part XI. Miscellaneous” of Article – Economic  
3 Development of the Annotated Code of Maryland be transferred to be Section(s) 11–1701  
4 and the subtitle “Subtitle 17. Miscellaneous” of Article – Labor and Employment of the  
5 Annotated Code of Maryland.

6 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
7 as follows:

8 **Article – Labor and Employment**

9 Subtitle 17. **[Miscellaneous] CYBER MARYLAND PROGRAM.**

11 (a) [(1)] In this [section] **SUBTITLE** the following words have the meanings  
12 indicated.

13 [(2)] (B) “Board” means the Cyber Maryland Board.

14 [(3)] (C) “Fund” means the Cyber Maryland Fund.

15 [(4)] (D) “Program” means the Cyber Maryland Program.

17 [(b)] (A) There is a Cyber Maryland Program in the [Corporation]  
18 **DEPARTMENT.**

19 [(c)] (B) The purposes of the Program are to:

20 (1) create and execute a talent pipeline that materially reduces workforce  
21 vacancies by July 1, 2026;

22 (2) serve as a one–stop shop for employers seeking to leverage cyber  
23 workforce development programs offered by the State and its partners;

24 (3) inform cybersecurity training and education programs operated by  
25 public or private entities with industry–driven needs;

26 (4) build the most advanced local and State information technology  
27 workforce in the nation, which, to the maximum extent possible, reflects the racial, gender,  
28 ethnic, and geographic diversity of the State;

29 (5) coordinate and accelerate cybersecurity research and innovation in the  
30 State; and

1 (6) support the efforts of the Department of Information Technology to  
2 improve the State government's cybersecurity posture, including State agencies, local  
3 government units, and critical infrastructure.

4 [(d)] (C) The Program shall:

5 (1) conduct ongoing research by collaborating with the Cybersecurity  
6 Association [of Maryland], Inc., Cybersecurity Talent Advisory Board to collect and analyze  
7 real-time industry data to identify cybersecurity workforce needs as described in the U.S.  
8 Chamber of Commerce Talent Pipeline Management Approach;

9 (2) use the results of the research described in item (1) of this subsection  
10 to increase the effectiveness of existing State cybersecurity workforce programs for  
11 employers in the State;

12 (3) facilitate partnerships for new training and education programs to  
13 address the workforce needs identified under item (1) of this subsection;

14 (4) develop a statewide strategic plan for cybersecurity workforce  
15 development, using the results of the research described in item (1) of this subsection and  
16 with input from the Cybersecurity Association [of Maryland], Inc., Cybersecurity Talent  
17 Advisory Board on or before December 1, 2023; [and]

18 (5) DEVELOP, PROMOTE, SUPPORT, AND INVEST IN TALENT  
19 IMPROVEMENT STRATEGIES, SUCH AS STRATEGIES THAT LEVERAGE THE U.S.  
20 CHAMBER OF COMMERCE TALENT PIPELINE MANAGEMENT APPROACH; AND

21 [(5)] (6) ensure that outcomes of the Program are inclusive and, to the  
22 maximum extent practicable, reflect the racial, gender, ethnic, and geographic diversity of  
23 the State.

24 (D) BEGINNING IN FISCAL YEAR 2026, THE PROGRAM, IN CONSULTATION  
25 WITH THE BOARD, SHALL AWARD COMPETITIVE GRANTS OR CONTRACTS FOR  
26 INFORMATION TECHNOLOGY OR OPERATIONAL TECHNOLOGY.

28 [(e)] (1) (A) There is a Cyber Maryland Fund.

29 [(2)] (B) The purposes of the Fund are to:

30 [(i)] (1) achieve the purposes identified under [subsection (c) of  
31 this section] § 11-1702(B) OF THIS SUBTITLE; and

1                    [(ii) (2)]       support innovative approaches to meeting cybersecurity  
2 workforce needs.

3                    [(3) (C)]       The [Corporation] **DEPARTMENT** shall administer the Fund.

4                    [(4) (i) (D)]       (1)    The Fund is a special, nonlapsing fund that is not  
5 subject to § 7-302 of the State Finance and Procurement Article.

6                    [(ii) (2)]       The State Treasurer shall hold the Fund separately, and  
7 the Comptroller shall account for the Fund.

8                    [(5) (E)]       The Fund consists of:

9                    [(i) (1)]       money appropriated in the State budget to the Fund; [and]

10                    (2)    **MONEY TRANSFERRED TO THE FUND IN ACCORDANCE WITH**  
11 **SUBSECTION (M) OF THIS SECTION; AND**

12                    [(ii) (3)]       any other money from any other source accepted for the  
13 benefit of the Fund.

14                    [(6) (F)]       The Fund may be used only for:

15                    [(i) (1)]       administrative expenses of the Program, including hiring  
16 staff in accordance with the State budget and hiring consultants and other professionals as  
17 necessary to implement, maintain, and administer the Program and the Fund; and

18                    [(ii) (2)]       providing grants to elementary and secondary schools,  
19 institutions of higher education, including community colleges, **EMPLOYERS, INCLUDING**  
20 **for-profit corporations, [and] nonprofit organizations, REGISTERED APPRENTICESHIP**  
21 **SPONSORS, LOCAL WORKFORCE BOARDS, INDUSTRY ASSOCIATIONS, LABOR UNIONS,**  
22 **LOCAL GOVERNMENTS, LOCAL OR REGIONAL ECONOMIC DEVELOPMENT ENTITIES,**  
23 **AND OTHER RELEVANT PARTNER ENTITIES AT THE DEPARTMENT'S DISCRETION** to  
24 operate cybersecurity programs based on the strategic plan of the Program.

25                    [(7) (G)]       The [Corporation] **DEPARTMENT** shall adopt standards to  
26 award grants under this section.

27                    [(8) (i) (H)]       (1)    The State Treasurer shall invest the money of the  
28 Fund in the same manner as other State money may be invested.

29                    [(ii) (2)]       Any interest earnings of the Fund shall be credited to the  
30 General Fund of the State.

1            **[(9)] (I)**        Expenditures from the Fund may be made only in accordance  
2 with the State budget.

3            **[(10)] (J)    (1)**    For fiscal year **[2025 and each year thereafter] 2026**, the  
4 Governor[:

5                    (i)       shall] **MAY** include in the annual budget bill an appropriation of  
6 **[\$99,000] \$3,100,000** for the Fund to be used for [talent pipeline management; and

7                    (ii)      may include in the annual budget bill an additional  
8 appropriation of \$250,000 for the Fund] **THE AWARDING OF GRANTS AND CONTRACTS**  
9 **UNDER § 11-1702(D) OF THIS SUBTITLE ALIGNED WITH THE STRATEGY OF AND**  
10 **APPROVED BY THE BOARD.**

11                    **(2)    FOR FISCAL YEAR 2027 AND EACH FISCAL YEAR THEREAFTER,**  
12 **THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION**  
13 **SUFFICIENT TO RUN THE PROGRAM.**

14                    **(3)    THE PROGRAM SHALL SEEK COST-SHARING OR COST-MATCHING**  
15 **AGREEMENTS FROM PARTNERS, INCLUDING THE FEDERAL GOVERNMENT, THE**  
16 **PRIVATE SECTOR, AND PHILANTHROPY, TO DOUBLE THE MONEY APPROPRIATED TO**  
17 **THE FUND UNDER PARAGRAPH (1) OF THIS SUBSECTION.**

18                    **[(11)] (K)**        Subject to the availability of funding, for fiscal year 2025 and  
19 each year thereafter, \$250,000 of the Fund shall be used for implementing the U.S.  
20 Chamber of Commerce Talent Pipeline Management Approach.

21                    **[(12)] (L)**        The Governor shall include in the annual budget bill an  
22 appropriation in an amount sufficient for the Program, **INCLUDING TO HIRE SUFFICIENT**  
23 **STAFF TO CARRY OUT ITS DUTIES.**

24                    **(M)    NOTWITHSTANDING § 7-302 OF THE STATE FINANCE AND**  
25 **PROCUREMENT ARTICLE AND ANY OTHER PROVISION OF LAW, THE UNSPENT**  
26 **BALANCE OF THE FOLLOWING PROGRAMS AND FUNDS THAT WAS MADE FOR THE**  
27 **FISCAL YEAR SHALL BE TRANSFERRED TO THE FUND AT THE CLOSE OF THAT FISCAL**

13                   [(2) (B)       The Board consists of the following members:

14                           [(i) (1)       the Senate and House of Delegates cochairs of the Joint  
 15 Committee on Cybersecurity, Information Technology, and Biotechnology;

16                           [(ii) (2)       the Secretary, or the Secretary’s designee;

17                           [(iii) (3)       the Secretary of [Labor] **COMMERCE**, or the Secretary’s  
 18 designee;

19                           [(iv) (4)       the Maryland Secretary of Veterans and Military  
 20 Families, or the Secretary’s designee;

21                           [(v) (5)       the Secretary of Information Technology, or the  
 22 Secretary’s designee;

23                   **(6) THE SECRETARY OF HIGHER EDUCATION, OR THE SECRETARY’S**  
 24 **DESIGNEE;**

25                   **(7) THE STATE SUPERINTENDENT OF SCHOOLS, OR THE**

1                    [(vi)] **(8)**     the Chair of the Board of Directors of the Cybersecurity  
2 Association [of Maryland], Inc., or the Chair's designee;

4 Chair's designee;

5                    **(10) THE CHIEF EXECUTIVE OFFICER OF THE MARYLAND**  
6 **TECHNOLOGY DEVELOPMENT CORPORATION (TEDCO), OR THE CHIEF**  
7 **EXECUTIVE OFFICER'S DESIGNEE; AND**

8                    [(viii)] **(11)** the following members, appointed by the Governor:

9                    [1.] **(I)**         five members from the private sector with  
10 cybersecurity needs;

11                    [2.] **(II)**         one representative from a nonprofit organization  
12 with expertise in cybersecurity talent development;

13                    [3.] **(III)**         one representative from a community college;

14                    [4.] **(IV)**         one representative from a 4-year, public HBCU  
15 college; and

16                    [5.] **(V)**         one representative from a 4-year, public college[;  
17 and

18                    (ix) the Chief Executive Officer, or the Chief Executive Officer's  
19 designee].

20                    [(3) (i)] **(C)**         **(1)** Subject to [subparagraph (ii)] **PARAGRAPH (2)** of  
21 this [paragraph] **SUBSECTION**, the members of the Board shall elect a chair from among  
22 the members of the Board.

23                    [(ii)] **(2)**         The chair may not be:

24                    [1.] **(I)**         a State employee; or

25                    [2.] **(II)**         the Chief Executive Officer **OF THE MARYLAND**  
26 **TECHNOLOGY DEVELOPMENT CORPORATION (TEDCO).**

27                    [(4)] **(D)**         The Board shall:

1                    [(i)] (1)        provide input regarding the development of the statewide  
2 cybersecurity workforce development strategic plan required under [subsection (d)(4) of  
3 this section] **§ 11-1702(C)(4) OF THIS SUBTITLE;**

4                    [(ii)] (2)        assist the Program with stakeholder outreach and  
5 engagement;

6                    [(iii)] (3)        help the Program explore synergies where appropriate  
7 with cybersecurity workforce development efforts by regional and county workforce  
8 development entities;

9                    [(iv)] (4)        coordinate as necessary with the [Maryland] Department  
10 of [Labor] **COMMERCE** and the Department; and

11                   [(v)] (5)        provide other advice and support for the Program.

12                   [(5)] (E)        A member of the Board:

13                   [(i)] (1)        may not receive compensation as a member of the Board;  
14 but

15                   [(ii)] (2)        is entitled to reimbursement for expenses under the  
16 Standard State Travel Regulations, as provided in the State budget.

17                   [(6) The Governor may remove an appointed member of the Board for  
18 incompetence, misconduct, or failure to perform the duties of the position.]

19                   (F) **TO THE EXTENT PRACTICABLE, THE MEMBERSHIP OF THE BOARD**  
20 **SHALL REFLECT THE RACIAL, GENDER, AGE, AND GEOGRAPHIC DIVERSITY OF THE**  
21 **STATE.**

22                   (G) (1) **THE TERM OF AN APPOINTED MEMBER OF THE BOARD IS 4 YEARS.**

23                   (2) **THE TERMS OF THE APPOINTED MEMBERS ARE STAGGERED AS**  
24 **REQUIRED BY THE TERMS PROVIDED FOR APPOINTED MEMBERS OF THE BOARD ON**  
25 **OCTOBER 1, 2025.**

26                   (3) **AT THE END OF A TERM, AN APPOINTED MEMBER CONTINUES TO**  
27 **SERVE UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES.**

28                   (4) **A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES**  
29 **ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED AND**  
30 **QUALIFIES.**

2 [(g)] (A) On or before December 1 each year, beginning in 2026, the Program, in  
3 conjunction with the [Corporation] DEPARTMENT, shall submit a report on the operation  
4 and performance of the Program to the Governor and, in accordance with § 2-1257 of the  
5 State Government Article, the General Assembly.

6 (B) THE REPORT REQUIRED UNDER SUBSECTION (A) OF THIS SECTION  
7 SHALL INCLUDE KEY PERFORMANCE METRICS ESTABLISHED BY THE DEPARTMENT  
8 THAT ARE ALIGNED WITH THE STATE STRATEGY AND GOALS FOR THE PROGRAM  
9 AND THE PROGRESS OF THE PROGRAM AGAINST THOSE METRICS.

10 SECTION 3. AND BE IT FURTHER ENACTED, That:

11 (a) It is the intent of the General Assembly that the amounts awarded in grants  
12 and contracts under § 11-702(d) of the Labor and Employment Article, as enacted by  
13 Section 2 of this Act, not exceed the following:

14 (1) \$1,000,000 for the establishment of cybersecurity clinics;

15 (2) \$500,000 to support the development of a  
16 service-based learning program for cybersecurity;

17 (3) \$500,000 to support transitioning veterans within the State who have  
18 cyber skills, adjacent skills, or relevant clearances acquired during their service;

19 (4) \$99,000 for talent pipeline management aligned with the framework  
20 from the U.S. Chamber of Commerce Foundation.

21 (5) \$250,000 to support existing or develop new programs and incentives  
22 for existing worker training;

23 (6) \$250,000 to support cybersecurity education at the kindergarten,  
24 elementary school, and secondary school levels, including at summer camps;

25 (7) \$250,000 for a marketing campaign, in consultation with the  
26 Department of Commerce, to attract cyber talent and industry to the State; and

27 (8) \$250,000 for the Maryland Statewide Computing Alignment to Locate  
28 your Education (SCALE) portal.

29 (b) It is the intent of the General Assembly that the cybersecurity clinics under  
30 subsection (a)(1) of this section:

31 (1) include five pilot programs, with each pilot program focused on one of  
32 the following customer groups:

- 1 (i) emergency services;
- 2 (ii) water;
- 3 (iii) elementary and secondary schools;
- 4 (iv) health; and
- 5 (v) small businesses and nonprofit entities; and
- 6 (2) will:
- 7 (i) provide cyber awareness and training to customers;
- 8 (ii) perform cybersecurity assessments for customers;
- 9 (iii) provide recommendations for necessary remediations; and
- 10 (iv) install free or reduced-cost cybersecurity tools as part of the
- 11 grant or at a reduced rate to the end customer.

12 SECTION 4. AND BE IT FURTHER ENACTED, That the terms of the initial

13 appointed members of the Cyber Maryland Board shall expire as follows:

- 14 (1) three members in 2026;
- 15 (2) two members in 2027;
- 16 (3) two members in 2028; and
- 17 (4) two members in 2029.

18 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect

19 October 1, 2025.
