### A BILL ENTITLED

#### 1 AN ACT concerning

# Local Government – Hiring and Promotion Preferences for Veterans and Spouses of Service Members and Veterans (Families Serve Act)

 $\mathbf{5}$ FOR the purpose of authorizing counties and municipalities to grant, by local law, a 6 preference in the hiring and promotion to eligible veterans, spouses of eligible service 7 members, spouses of certain eligible veterans and eligible service members, and 8 surviving spouses of deceased eligible veterans; authorizing counties and 9 municipalities to adopt a local law that allows for the application of a certain credit on a selection test for eligible spouses, eligible veterans, spouses of certain eligible 10 11 veterans, and surviving spouses of deceased eligible veterans; and generally relating 12to hiring and promotion preferences for veterans and spouses of service members 13 and veterans.
