2 **Caroline County – Alcoholic Beverages – Special Event Venue License and**  
3 **Multiple Event Licenses**

4 FOR the purpose of establishing the ~~rural~~ special event venue beer, wine, and liquor license  
5 ~~as a multiple event license~~ in Caroline County; authorizing the Board of License  
6 Commissioners for Caroline County to issue the license to the owner of a venue with  
7 a certain zoning classification; authorizing holders of certain multiple event licenses  
8 in Caroline County to store alcoholic beverages on the licensed premises for a certain  
9 purpose; and generally relating to alcoholic beverages licenses in Caroline County.

26 (A) ~~THERE IS A RURAL~~ **THERE IS A RURAL SPECIAL EVENT VENUE BEER, WINE, AND LIQUOR**  
 27 **LICENSE.**

28 (B) **THE BOARD MAY ISSUE THE LICENSE:**

29 (1) ~~TO THE OWNER OF A VENUE THAT IS ZONED AS A RURAL~~ **TO THE OWNER OF A RURAL SPECIAL**  
 30 **EVENT VENUE UNDER COUNTY LAW; AND**

31 (2) (I) **TO THE SAME APPLICANT FOR ALL EVENTS FOR WHICH THE**  
 32 **LICENSE IS ISSUED; AND**

1 (II) FOR USE AT ONLY ONE PREMISES.

2 (C) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,  
3 AND LIQUOR FOR ON-PREMISES CONSUMPTION.

4 (D) THE LICENSE MAY NOT BE TRANSFERRED TO ANOTHER LOCATION.

5 (E) A LICENSE HOLDER MAY SELL BEER, WINE, AND LIQUOR DURING THE  
6 HOURS SET IN COUNTY LAW FOR ~~RURAL~~ SPECIAL EVENT VENUES.

7 (F) A LICENSE HOLDER MAY PURCHASE BEER, WINE, AND LIQUOR ONLY  
8 FROM A LICENSED WHOLESALER.

9 (G) A LICENSE HOLDER IS SUBJECT TO THE ALCOHOL AWARENESS  
10 TRAINING REQUIREMENTS UNDER § 4-505 OF THIS ARTICLE AND § 15-1902 OF THIS  
11 TITLE.

12 (H) THE FEE FOR A ~~RURAL~~ SPECIAL EVENT VENUE LICENSE IS:

13 (1) \$250 FOR NOT MORE THAN 10 EVENTS PER YEAR;

14 (2) \$500 FOR NOT MORE THAN 20 EVENTS PER YEAR;

15 (3) \$750 FOR NOT MORE THAN 30 EVENTS PER YEAR; AND

16 (4) \$1,000 FOR NOT MORE THAN 40 EVENTS PER YEAR.

18 (a) Instead of issuing individual event licenses, the Board may issue a multiple  
19 event license for a particular class of license.

20 (b) The number of days for which a multiple event license may be used by a single  
21 applicant may not exceed 40 per calendar year.

22 (c) (1) A multiple event license shall be issued:

23 (i) for one premises only; and

24 (ii) except as provided in paragraph (2) of this subsection, to the  
25 same applicant for all events for which the license is issued.

26 (2) The Board may:

27 (i) approve in writing a substitute applicant; and

1           (ii) before approving a substitute applicant, hold a hearing.

2           (d) A server who is certified as having completed an alcohol awareness program  
3 shall be on the premises for which a multiple event license is issued when alcoholic  
4 beverages are served.

5           **(E) (1) THE HOLDER OF A MULTIPLE EVENT LICENSE UNDER THIS**  
6 **SECTION MAY STORE ALCOHOLIC BEVERAGES ON THE LICENSED PREMISES**  
7 **BETWEEN INDIVIDUAL LICENSED EVENTS IF THE ALCOHOLIC BEVERAGES:**

8                   **(I) ARE IN A SPECIALLY IDENTIFIED LOCKED AND SECURED**  
9 **LOCATION; AND**

10                   **(II) ARE NOT SOLD OR CONSUMED EXCEPT DURING LICENSED**  
11 **EVENT HOURS FOR LICENSED EVENT PURPOSES.**

12           **(2) (I) THE LICENSE HOLDER SHALL KEEP COMPLETE AND**  
13 **ACCURATE RECORDS OF ALL ALCOHOLIC BEVERAGES PURCHASED AND SOLD ON**  
14 **THE LICENSED PREMISES.**

15                   **(II) THE RECORDS SHALL BE:**

16                           **1. MAINTAINED ON THE LICENSED PREMISES FOR 2**  
17 **YEARS; AND**

18                           **2. AVAILABLE FOR INSPECTION BY AUTHORIZED**  
19 **PERSONNEL OF THE COMPTROLLER, THE EXECUTIVE DIRECTOR, AND THE BOARD.**

20                   **(III) THE RECORDS SHALL INCLUDE A COMPLETED PRE- AND**  
21 **POST-INVENTORY OF ALL ALCOHOLIC BEVERAGES FOR EACH INDIVIDUAL EVENT.**

22           **(3) AUTHORIZED PERSONNEL OF THE COMPTROLLER, THE**  
23 **EXECUTIVE DIRECTOR, AND THE BOARD MAY INSPECT THE PREMISES OF THE**  
24 **LICENSE HOLDER AS PROVIDED UNDER § 6-202 OF THIS ARTICLE.**

25           **(4) A LICENSE HOLDER WHO VIOLATES THIS SUBSECTION IS SUBJECT**  
26 **TO:**

27                   **(I) FOR THE FIRST OFFENSE, A FINE OF \$100; AND**

28                   **(II) FOR A SUBSEQUENT OFFENSE, A FINE NOT EXCEEDING \$500**  
29 **AND DENIAL OF FUTURE REQUESTS FOR A LICENSE FOR AN INDIVIDUAL EVENT OR A**  
30 **SPECIAL MULTIPLE EVENT LICENSE.**

31           **[(e)] (F) (1) The fee for a multiple event license is:**

- 1           (i)     \$250 for not more than 10 events per year;  
 2           (ii)    \$500 for not more than 20 events per year;  
 3           (iii)   \$750 for not more than 30 events per year; and  
 4           (iv)    \$1,000 for not more than 40 events per year.

5           (2)    The Board may not issue a refund if the license holder holds fewer  
 6 events during the calendar year than the number of events that the license holder is  
 7 entitled to hold.

17           ~~(2)    are not sold or consumed except during licensed event hours for licensed~~  
 18 ~~event purposes.~~

19           (c)    (1)    ~~A license holder shall keep complete and accurate records of all~~  
 20 ~~alcoholic beverages purchased and sold on the licensed premises.~~

21           ~~(2)    The records shall be:~~

22           ~~(i)    maintained on the licensed premises for 2 years; and~~

23           ~~(ii)   available for inspection by authorized personnel of the~~  
 24 ~~Comptroller, the Executive Director, and the Board.~~

25           ~~(3)    The records shall include a completed pre and post inventory of all~~  
 26 ~~alcoholic beverages for each individual event.~~

27           (d)    ~~Authorized personnel of the Comptroller, the Executive Director, and the~~  
 28 ~~Board may inspect the premises of a license holder as provided under § 6-202 of this article.~~

- 1        ~~(e) A license holder who violates this section is subject to:~~
- 2            ~~(1) for the first offense, a fine of \$100; and~~
- 3            ~~(2) for a subsequent offense, a fine not exceeding \$500 and denial of future~~
- 4 ~~requests for a license for an individual event or a special multiple event license.~~

5        SECTION ~~3~~ 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 6        July 1, 2025.
