A BILL ENTITLED

1 AN ACT concerning

2 **Property Tax – Exemption for Blind Individuals – Alteration**

3 FOR the purpose of increasing the amount of a certain property tax exemption for dwelling
4 houses owned by blind individuals or their surviving spouses; and generally relating
5 to a property tax exemption for blind individuals.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

12 That the Laws of Maryland read as follows:

13 **Article – Tax – Property**

14 7-207.

15 (a) (1) In this section the following words have the meanings indicated.

16 (2) “Blind individual” means an individual who has a permanent
17 impairment of both eyes that causes:

18 (i) central visual acuity, with corrective glasses, of 20/200 or less in
19 the better eye; or

20 (ii) central visual acuity of more than 20/200 if there is a field defect
21 in which the peripheral field has contracted so that the widest diameter of visual field
22 subtends an angular distance no greater than 20 degrees in the better eye.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



(3) “Dwelling house”:

(i) means real property that is:

1. the legal residence of a blind individual or a surviving

2. occupied by not more than 2 families; and

6 (ii) includes the lot or curtilage, and structures necessary to use the
7 real property as a residence.

(4) "Surviving spouse" means the surviving spouse of a blind individual, if the surviving spouse has not remarried.

13 (1) a blind individual; or

14 (2) a surviving spouse.

15 (c) Except as provided in subsection (d) of this section, after a blind individual
16 dies, the surviving spouse shall receive an exemption under this section, if the dwelling
17 house was formerly exempt under this section.

18 (d) (1) Except as provided in paragraph (2) of this subsection, an exemption
19 under this section shall be granted in addition to any other exemption authorized by law.

(2) An individual may receive an exemption under this section or under § 7–208 of this subtitle but not under both.

22 (e) An exemption under this section shall be prorated by the supervisor for any
23 part of a taxable year that remains after the date in the year when the blind individual or
24 surviving spouse applies for the exemption.

25 (f) (1) The governing body of a county or a municipal corporation may
26 authorize, by law, a refund to a blind individual who receives an exemption under this
27 section for any county or municipal corporation property tax paid in the taxable years in
28 which an exemption was authorized but not granted.

29 (2) A county or municipal corporation may not authorize a refund for a
30 surviving spouse.

31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
32 1, 2025, and shall be applicable to all taxable years beginning after June 30, 2025.
