CHAPTER _____

1 AN ACT concerning

2 **Charles County – Off-Highway Recreational Vehicles – Regulation and**
3 **Enforcement**

4 FOR the purpose of authorizing Charles County to regulate the operation of off-highway
5 recreational vehicles in the county and to impound an off-highway recreational
6 vehicle that is the subject of certain alleged motor vehicle violations; and generally
7 relating to off-highway recreational vehicles in Charles County.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Transportation**

16 25–102.

17 (a) The provisions of the Maryland Vehicle Law do not prevent a local authority,
18 in the reasonable exercise of its police power, from exercising the following powers as to
19 highways under its jurisdiction:

1 (1) Subject to the provisions of § 21–1003.1 of this article, regulating or
2 prohibiting the stopping, standing, or parking of vehicles;

3 (2) Regulating traffic by means of police officers or traffic control devices;

4 (3) Regulating or prohibiting processions or assemblies on highways;

5 (4) Designating particular highways or separate roadways as one–way
6 highways and requiring that all vehicles on them move in one specified direction;

7 (5) Regulating the speed and weight of vehicles in public parks;

8 (6) Designating any highway as a through highway or designating any
9 intersection as a stop intersection or a yield intersection;

10 (7) Restricting the use of highways as provided in Title 24 of this article;

11 (8) Regulating the operation of bicycles, requiring them to be registered,
12 and imposing a registration fee;

13 (9) Regulating or prohibiting the turning of vehicles or specified types of
14 vehicles at intersections;

15 (10) Altering speed limits as provided in Title 21, Subtitle 8 of this article;

16 (11) Regulating through truck traffic and prohibiting trucks from using any
17 highway or alley that is not designated or maintained as a part or extension of the State or
18 federal highway system, provided the local authority has designated an adequate alternate
19 route for diverted truck traffic;

20 (12) Adopting any other traffic regulations as specifically authorized in the
21 Maryland Vehicle Law;

22 (13) Regulating taxi stands, including taxi stands in the middle of a block;

23 (14) (i) In this paragraph, “all–terrain vehicle” includes an off–highway
24 motorcycle.

25 (ii) 1. Subject to item 2 of this item, except in Allegany County
26 and Garrett County, designating a certain portion of highways upon which snowmobiles
27 may travel for the sole purpose of gaining access to snowmobile trails; but

28 2. Designating only those highways which divide snowmobile
29 trails and which would otherwise obstruct direct access between snowmobile trails; and

30 (iii) In Allegany County and Garrett County:

1 1. Authorizing a person to:

2 A. Cross a highway on an all-terrain vehicle or a snowmobile
3 at a right angle at a speed of not more than 25 miles per hour; or

4 B. Operate an all-terrain vehicle or a snowmobile on not
5 more than 5 miles of highway at a speed of not more than 25 miles per hour; and

6 2. Designating a certain portion of highways upon which
7 all-terrain vehicles and snowmobiles may travel at a speed of not more than 25 miles per
8 hour for the sole purpose of gaining access to:

9 A. Trails on which the operation of an all-terrain vehicle or
10 a snowmobile is authorized;

11 B. Fields; or

12 C. Another area where the operation of an all-terrain vehicle
13 or a snowmobile is authorized;

14 (15) Requiring a motorized minibike to be permitted by the local authority,
15 and imposing a permit fee;

16 (16) In Allegany County, designating crossings on county highways where a
17 person operating a golf cart may cross the highway for continued access to any portion of a
18 golf course;

19 (17) Restricting use of a low speed vehicle on a highway;

20 (18) Authorizing an emergency vehicle not subject to registration to operate
21 on a highway while performing an emergency service as defined in § 19-103 of this article;
22 [and]

23 (19) Authorizing a person to cross a highway on an all-terrain vehicle at a
24 right angle to access a farm or to move from one part of a farm to another part of the same
25 farm; AND

26 **(20) IN CHARLES COUNTY:**

27 **(I) REGULATING THE OPERATION OF OFF-HIGHWAY**
28 **RECREATIONAL VEHICLES;**

29 **(II) REQUIRING OFF-HIGHWAY RECREATIONAL VEHICLES TO**
30 **BE REGISTERED BY THE COUNTY AND IMPOSING A REGISTRATION FEE;**

1 (III) IMPOSING AGE RESTRICTIONS ON THE OPERATION OF
2 OFF-HIGHWAY RECREATIONAL VEHICLES; AND

3 (IV) AUTHORIZING THE IMPOUNDMENT OF AN OFF-HIGHWAY
4 RECREATIONAL VEHICLE THAT IS THE SUBJECT OF AN ALLEGED VIOLATION OF:

- 5 1. TITLE 21, SUBTITLE 9 OF THIS ARTICLE;
- 6 2. § 6-404 OF THE CRIMINAL LAW ARTICLE; OR
- 7 3. § 6-405 OF THE CRIMINAL LAW ARTICLE.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 2025.
