 26 That the Laws of Maryland read as follows:

1 **(2) “ABANDONED CEMETERY” MEANS A CEMETERY FOR WHICH:**

2 **(I) 1. THE ORGANIZATION ESTABLISHED TO ENGAGE IN THE**
3 **OPERATION OF THE CEMETERY HAS BEEN TERMINATED, HAS BEEN SUBJECT TO**
4 **ADMINISTRATIVE DISSOLUTION BY THE STATE, OR HAS OTHERWISE CEASED TO**
5 **EXIST; AND**

6 **2. TITLE HAS NOT BEEN CONVEYED;**

7 **(II) THERE IS NO PROPERTY OWNER LISTED IN THE RECORDS OF**
8 **THE STATE DEPARTMENT OF ASSESSMENTS AND TAXATION;**

9 **(III) THE PROPERTY HAS BEEN CONDEMNED; OR**

10 **(IV) NO PERSON WHO IS LEGALLY RESPONSIBLE FOR THE**
11 **PROPERTY CAN BE FOUND AND LEGAL OWNERSHIP OF THE PROPERTY CANNOT BE**
12 **DETERMINED.**

13 **(3) “FUND” MEANS THE ABANDONED AND NEGLECTED CEMETERIES**
14 **FUND.**

15 **(4) “NEGLECTED CEMETERY” MEANS A CEMETERY FOR WHICH:**

16 **(I) TWO OR MORE CITATIONS HAVE BEEN ISSUED BY A COUNTY**
17 **OR MUNICIPAL CORPORATION AGAINST THE PROPERTY FOR FAILURE TO MAINTAIN**
18 **THE PROPERTY;**

19 **(II) THE PROPERTY HAS FALLEN INTO DISREPAIR DUE TO**
20 **NEGLECT AND INSUFFICIENT MAINTENANCE;**

21 **(III) THE PROPERTY HAS BEEN THE OBJECT OF VANDALISM,**
22 **LOITERING, OR OTHER CRIMINAL CONDUCT; OR**

23 **(IV) THERE HAS BEEN PHYSICAL DESTRUCTION OR**
24 **DETERIORATION OF THE PROPERTY.**

25 **(B) THERE IS AN ABANDONED AND NEGLECTED CEMETERIES FUND.**

26 **(C) THE PURPOSE OF THE FUND IS TO PROVIDE FOR THE CARE,**
27 **PRESERVATION, MAINTENANCE, AND RESTORATION OF ABANDONED AND**
28 **NEGLECTED CEMETERIES IN THE STATE.**

29 **(D) THE SECRETARY SHALL ADMINISTER THE FUND.**

1 (E) (1) THE FUND IS A SPECIAL, NONLAPSING FUND THAT IS NOT
2 SUBJECT TO § 7-302 OF THE STATE FINANCE AND PROCUREMENT ARTICLE.

3 (2) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY,
4 AND THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.

5 (F) THE FUND CONSISTS OF:

6 (1) ~~THE NET PROCEEDS FROM CONTRIBUTIONS UNDER THE INCOME~~

14 OF ABANDONED AND NEGLECTED CEMETERIES;

15 (II) ADMINISTERING THE FUND THROUGH DISTRIBUTION TO AN
16 ADMINISTRATIVE COST ACCOUNT IN THE DEPARTMENT; AND

17 (III) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION,
18 PROMOTING DONATIONS TO THE FUND THROUGH DISTRIBUTION TO A PROMOTION
19 COST ACCOUNT IN THE DEPARTMENT.

20 (2) NOT MORE THAN 5% OF THE NET PROCEEDS OF THE FUND MAY
21 BE USED UNDER PARAGRAPH (1)(III) OF THIS SUBSECTION.

22 (H) (1) THE STATE TREASURER SHALL INVEST THE MONEY OF THE FUND
23 IN THE SAME MANNER AS OTHER STATE MONEY MAY BE INVESTED.

24 (2) ANY INTEREST EARNINGS OF THE FUND SHALL BE CREDITED TO
25 THE FUND.

26 (I) EXPENDITURES FROM THE FUND MAY BE MADE ONLY IN ACCORDANCE
27 WITH THE STATE BUDGET.

28 (J) MONEY EXPENDED FROM THE FUND FOR THE PRESERVATION, CARE,
29 AND MAINTENANCE OF ABANDONED AND NEGLECTED CEMETERIES IS

1 SUPPLEMENTAL TO AND IS NOT INTENDED TO TAKE THE PLACE OF FUNDING THAT
 2 OTHERWISE WOULD BE APPROPRIATED FOR THE OFFICE OF CEMETERY
 3 OVERSIGHT.

4 (K) THE GOVERNOR MAY INCLUDE IN THE ANNUAL BUDGET BILL AN
 5 APPROPRIATION OF \$250,000 TO THE FUND.
