Montgomery History, founded as the Montgomery County Historical Society, has been serving the county and the region through its research library, exhibits, adult programs, educational activities for students, publications, Speakers Bureau, and history-themed conferences since 1944. Montgomery History's mission is to collect, preserve, interpret, and share the history of all Montgomery County residents and communities. As the only organization addressing the entire scope of county history, we serve a distinctive role as a cultural repository and source of dependable information. Our goal is to help create a shared sense of place among residents old and new and to build a safe and welcoming community.

11. Description and Purpose of Project (Limit length to visible area)

To rectify an issue that has plagued us since the 1980s, we are developing a new home for our Sween Library; flex space for public programming (exhibits, hands-on workshops, lectures, events, etc.); a studio for creating digital content; and its administrative offices. Our intent is to bring all these activities under one roof as the Montgomery County History Center. We have recently purchased the (c.1930) Farmers Banking and Trust building at 4 Courthouse Square in the Rockville Courthouse Historic District to fill these needs. This iconic building is the only commercial Art Deco building in Rockville that survived urban renewal. It will require extensive interior modifications--most notably the installation of an elevator to serve all four floors, a sprinkler system throughout, and significant HVAC upgrades--to make it accessible to the public and to meet professional standards for the storage and care of the invaluable materials in our library and archives.

28. Comments

The new Montgomery County History Center at 4 Courthouse Square will bring the historic Farmers Banking and Trust building back to life, helping to revitalize a key corridor in downtown Rockville. The building will provide a home for all our functions under one roof (except storage of our artifacts which will be across the street in the County-owned Grey Courthouse). The former bank lobby, with 25-foot ceilings, will provide open flex space for educational programs, hands-on workshops, symposia, exhibits, community events, and other public activities. Accessible restrooms and a catering kitchen will also be installed on the main floor. The second and third levels will house the Sween Library and Special Collections, including an expansive reading room and professional-grade archival storage. On the top floor will also be a recording studio for oral histories and virtual programs, as well as our administrative offices. A sprinkler system will be installed to serve the entire structure.

The studio to produce digital content will occupy a relatively small space, but it will be critically important to our growing audience, especially younger people who engage with our recorded presentations, podcasts, and oral history interviews. Utilization of new technologies allows us to reach larger, more diverse audiences (in terms of age, race, geography, physical abilities, etc.) who may otherwise face barriers to access. Two examples demonstrate the power of these technologies. Our weekly History Conversations program, offered for free via Zoom, has drawn an audience from 48 states and seven foreign countries. And a recent Zoom program about the resilience of the American Constitution, featuring Rep. Jamie Raskin, drew an audience of 650 households and the video was viewed another 4,000 times online. Our plans for FY26 and beyond are dependent upon having a home for creating professional quality digital media.

Significantly, the new space will allow us to deepen our commitment to using historical inquiry, education, and engagement to reach new audiences, and contribute to public discussions about issues of contemporary relevance. The timing is particularly auspicious in light of the nations and the County's upcoming 250th anniversaries in 2026. (The opening is anticipated for the summer of 2026, just before the countys anniversary on September 6, 2026.) Events and exhibitions representing the theme of An Unfinished Revolution will be developed in partnership with organizations, schools, and local government agencies. We anticipate these events will draw people to Rockville to deepen their understanding of how this country, and our county, have developed over the last 25 decades.

In short, the Montgomery County History Center will be a one-of-a-kind facility serving residents of the county and beyond, helping them better understand their shared past in order to forge a better tomorrow for future generations. Above all, it will make history accessible to all, which in turn helps us to build safer and more welcoming communities for ourselves and our neighbors.
