11. Description and Purpose of Project (Limit length to visible area)

To address escalating community concerns regarding crime, traffic violations, and slow emergency response times within the Good Luck Rd residential area, we propose the establishment of a satellite police station. This initiative aims to enhance public safety and foster stronger community relations by deploying 2-4 police, code, and parking officers within a leased modular building situated in the underutilized parking lot adjacent to Good Luck Rd. This strategic location will significantly improve response times to a large portion of the residential area, increase visible police presence to deter crime, and facilitate proactive community policing strategies. Funding is requested for purchase of the modular building, encompassing installation, utilities, and maintenance, alongside the necessary personnel and operational costs to ensure effective and sustainable service delivery.
