Gaming - Sports Wagering - Sports Wagering Facility Licensees

This bill authorizes competitively awarded Class B-1 and B-2 sports wagering facility licensees to submit a written request to the State Lottery and Gaming Control Commission (SLGCC) to relocate a Class B sports wagering facility. SLGCC may grant a relocation request if the licensee was originally issued a Class B sports wagering facility license before October 1, 2023, and the new location for the sports wagering facility is within the same county, complies with specified location requirements, and is approved by the Sports Wagering Application Review Commission (SWARC). Additionally, the bill authorizes a Class A sports wagering facility licensee that provides sports wagering services on behalf of a Class B sports wagering facility licensee to utilize the Class A sports wagering facility's branding and loyalty rewards program at the Class B sports wagering facility. However, an individual may not utilize the account wallet that one maintains with the Class A sports wagering facility when placing wagers with the Class B sports wagering licensee. With the Class A sports wagering facility licensee's approval, the applicable Class B sports wagering facility licensee may utilize and market the Class A sports wagering facility licensee's branding and loyalty rewards programs in the same manner as the Class A sports wagering facility licensee. **The bill takes effect July 1, 2025.**

Fiscal Summary

State Effect: The bill does not materially affect State revenues. The State Lottery and Gaming Control Agency (SLGCA) and SWARC can approve any relocation requests and SLGCA can monitor compliance with existing resources.

Local Effect: None.

Small Business Effect: Minimal.

Analysis

Current Law: Chapter 492 of 2020, a constitutional amendment approved by the voters at the November 2020 general election, authorized sports and event wagering, contingent upon implementation legislation passed by the General Assembly. Chapter 356 of 2021 implemented sports wagering in the State and provides for regulation of sports wagering and fantasy gaming competitions. Licensees receive 85% of proceeds from sports wagering and fantasy gaming and the State receives 15%, as well as license fee revenues. Any winnings on a sports event not claimed within 182 days after the wager is won revert to the Problem Gambling Fund.

Sports wagering licenses are awarded by SWARC, the members of which were appointed by the Governor, the President of the Senate, and the Speaker of the House. SWARC must review applications for sports wagering facility and mobile sports wagering licensure, and SLGCC and the Department of Legislative Services must staff SWARC. SWARC terminates on January 1, 2028, but the Governor may reconstitute SWARC under specified circumstances.

Specified Class A (casinos, professional sports stadiums, and horse racing licensees) and Class B (specified horse racing tracks, off-track facilities, and specified bingo halls) sports wagering facility licensees designated under the law are eligible to receive licenses under a noncompetitive process. SWARC may also conduct a competitive process to award an additional 30 Class B-1 or B-2 facility licenses and 60 mobile sports wagering licenses. SWARC may not award a Class B sports wagering facility license to an applicant who is eligible for or holds a Class A sports wagering facility license.

Generally, SWARC may not award a Class B-1 or B-2 sports wagering facility license to an applicant whose sports wagering facility will be located:

- within a 15-mile radius of a Class A-1 or A-2 sports wagering facility located in Allegany, Cecil, or Worcester counties;
- with respect to an application for a sports wagering facility license submitted before June 1, 2025, within a 15-mile radius of specified Class B-1 or B-2 sports wagering facilities in Charles County;
- with respect to an application for a sports wagering facility license submitted before June 1, 2025, within a 10-mile radius of specified Class B-1 or B-2 sports wagering facilities in Carroll County;
- with respect to an application for a sports wagering facility license submitted before June 1, 2025, within a 5-mile radius of specified Class B-1 or B-2 sports wagering facilities in Frederick County;

- within a 1.5-mile radius of a Class A-1 or A-2 sports wagering facility located in counties other than Allegany, Cecil, or Worcester counties; or
- within a 1.5-mile radius of any other Class B-1 or B-2 sports wagering facility.

Chapter 638 of 2023 authorized SLGCC and SWARC to consider a request to amend a Class B-2 sports wagering facility license application for the purpose of altering the proposed location of the facility if a sports wagering facility license was awarded to the applicant by February 15, 2023, and a written request to amend the application was received by December 31, 2023.

A sports wagering facility licensee may contract with another sports wagering facility licensee to provide sports wagering services on behalf of the licensee at a location where the licensee is authorized to accept wagers on sporting events.

If a sports wagering licensee authorized to accept wagers at a stadium contracts with a video lottery operator (or an affiliate or subsidiary of that video lottery operator), the video lottery operator's facility must be located in the same county as the stadium.

Appendix – Maryland Gaming

The State of Maryland has authorized and awarded six video lottery operation licenses in Baltimore City and Allegany, Anne Arundel, Cecil, Prince George's, and Worcester counties with a maximum number of 16,500 video lottery terminals (VLTs) allotted in the State. The opening date and the number of VLTs and table games in operation for each facility as of December 2024 are shown in **Exhibit 1**.

Video Lottery Terminals and Table Game Revenues

The estimated revenues from VLTs and table games in fiscal 2026 through 2030 are shown in **Exhibit 2**. A total of \$2.0 billion in gross gaming revenues is projected in fiscal 2026, including \$618.7 million to be distributed to the Education Trust Fund.

Chapter 492, a constitutional amendment approved by the voters at the November 2020 general election, authorized sports and event wagering, contingent upon implementation legislation passed by the General Assembly. Chapter 356 of 2021 implemented sports wagering in the State and provides for regulation of sports wagering and fantasy gaming competitions. Licensees receive 85% of proceeds from sports wagering and fantasy gaming and the State receives 15%, as well as license fee revenues. State revenues from sports wagering and fantasy gaming and their distributions in fiscal 2026 through 2030 are shown in **Exhibit 3**.
