FISCAL AND POLICY NOTE First Reader

House Bill 283 Judiciary (Delegate Young)

Public Safety - Safe Neighborhoods - Pilot Program

This bill requires the Governor's Office of Crime Prevention and Policy (GOCPP) to establish a Safe Neighborhoods Pilot Program to, among other things, purchase doorbell cameras or security systems with doorbell cameras and install them in the homes of residents of high-crime areas who apply to participate in the program. GOCPP must coordinate with local law enforcement agencies and adopt implementing regulations, as specified. By December 31, 2027, GOCPP must report to the General Assembly specified information relating to the program and publicly post the report on its website. Beginning in fiscal 2027, the Governor must include in the annual budget bill an appropriation of \$5.0 million for the program to be used only to (1) carry out the purposes of the program and (2) cover expenses incurred by GOCPP that are attributable to the program. **The bill terminates September 30, 2028.**

Fiscal Summary

State Effect: General fund expenditures increase by \$117,200 in FY 2026 (for contractual staff) and by \$5.0 million annually from FY 2027 through 2029 (which reflects the bill's mandated appropriation). Revenues are not affected. **This bill establishes a mandated appropriation from FY 2027 through 2029.**

Local Effect: Local government finances are not anticipated to be materially affected. It is assumed that local law enforcement agencies can implement the bill using existing resources.

Small Business Effect: Potential meaningful.

Analysis

Bill Summary: GOCPP must establish the Safe Neighborhoods pilot program to (1) purchase doorbell cameras or security systems with doorbell cameras and install the cameras or systems in the homes of residents who apply to participate in the program; (2) engage community organizations and residents to promote community participation in the program; (3) provide training for residents on the use of a doorbell camera or security system with a doorbell camera, including how to access video produced by the camera; (4) establish a process for residents to contact law enforcement in order to submit video obtained by a doorbell camera as evidence; and (5) provide information to residents on the process for the submission of video captured by a doorbell camera to law enforcement.

GOCPP, in coordination with local law enforcement agencies, must (1) identify high-crime areas within local communities in the State; (2) establish a process for residents of high-crime areas identified by the office to apply to participate in the program; and (3) facilitate training for residents on the use of doorbell cameras and security systems with doorbell cameras.

By December 31, 2027, GOCPP must report to the General Assembly on:

- the crime rate within the identified high-crime areas following the implementation of the program;
- the total number of crimes solved with the aid of evidence obtained by cameras provided through the program;
- the sense of security among resident participants of the program;
- the total number of participants in the program; and
- the usefulness and viability of the program based on a cost-benefit analysis.

GOCPP must adopt regulations to implement the program, including regulations that:

- ensure that a doorbell camera or security system with a doorbell camera that is provided to a resident of a high-crime area includes two years of service at no cost to the resident;
- prohibit a law enforcement agency from compelling a resident to share footage obtained by a doorbell camera or security system with a doorbell camera provided through the program; and
- include measures that protect the privacy of residents and ensure that any data collected is securely stored and protected from unauthorized access or breaches.

Current Law: The Governor is required to include in the annual budget bill an appropriation of \$3.6 million for Baltimore City to be used only to (1) provide grants to HB 283/ Page 2

community-based organizations to operate Safe Streets Initiatives in Baltimore City and (2) cover expenses incurred by Baltimore City that are attributable to the Safe Streets Initiative, including personnel hired by Baltimore City and assigned to a Safe Streets Initiative. The funds must be used solely to supplement, and not supplant, funds otherwise available for Safe Streets Initiatives in Baltimore City.

A grant made with the appropriated funds may not (1) require a matching fund; (2) exceed \$600,000 per Safe Streets Initiative; or (3) supplant grant funding otherwise available for Safe Streets Initiatives.

By December 31 each year, the Mayor of Baltimore City must report to specified committees of the General Assembly on (1) the effectiveness of Safe Streets Initiatives in Baltimore City; (2) the status of all Safe Streets Initiatives in Baltimore City, as specified; and (3) any other information considered necessary by the Mayor of Baltimore City.

The fiscal 2026 budget as introduced includes \$3.6 million for Baltimore City Safe Streets.

"Safe Streets Initiative" means a violence prevention or intervention program operated by a community-based organization in a neighborhood that is disproportionately affected by violent crime.

Chapter 746 of 2024 established the Maryland Entertainment District Security Grant Program to assist community organizations, nonprofit entities, and local governments to fund security operations during times of high pedestrian traffic in entertainment districts from which a higher-than-average number of calls for police assistance in response to reported crime are placed. In addition, Chapter 746 established the Maryland Entertainment District Security Grant Program Fund as a special fund administered by GOCPP to provide funding for grants awarded under the program. Beginning in fiscal 2026, the Governor may annually appropriate up to \$1.0 million to the fund. The fiscal 2026 budget as introduced includes \$250,000 for the Maryland Entertainment District Security Grant Program.

The fund may be used only (1) to fund grants to community organizations, nonprofit entities, and local governments through the program and (2) for costs to administer the fund. Money expended from the fund for the program is supplemental to and is not intended to take the place of funding that otherwise would be appropriated for the program.

"Community organization" means a neighborhood association recognized by the political subdivision in which it is located.

"Entertainment district" means a one-half square mile area in the State in which one of the following is present: (1) a high density of establishments licensed to serve alcoholic beverages for on-site consumption; (2) a high density of establishments that are hookah

bars; or (3) a high density of establishments that regularly host live entertainment for their patrons or members of the public.

State Expenditures: General fund expenditures increase by \$117,172 in fiscal 2026 and by \$5.0 million annually from fiscal 2027 through 2029, as discussed below.

Mandated Funding – Fiscal 2027 through 2029

General fund expenditures increase by \$5.0 million annually from fiscal 2027 through 2029 due to the bill's mandated appropriation – to carry out the purposes of the program and to cover expenses incurred by GOCPP that are attributable to the program (discussed below). The Department of Legislative Services notes that the bill terminates September 30, 2028, (at the end of the first quarter of fiscal 2029); it is assumed that despite the termination date, the mandated appropriation applies for fiscal 2029 as the fiscal 2029 budget will have been enacted by the time the bill terminates.

Administrative Expenditures Beginning in Fiscal 2026

General fund expenditures increase by \$117,172 in fiscal 2026, which reflects the bill's October 1, 2025 effective date. This estimate reflects the cost of hiring two contractual program coordinators to develop and implement the pilot program. It includes salaries, fringe benefits, one-time start-up costs, and ongoing operating expenses. Even though the mandated funding for the program does not begin until fiscal 2027, GOCPP needs to hire the contractual positions in fiscal 2026 to identify high-crime areas eligible for the program and establish the process for eligible residents to apply to participate in the program.

Future year administrative expenditures, which are covered by the mandated funding, total \$131,118 in fiscal 2027, \$136,810 in fiscal 2028, and \$35,688 in fiscal 2029. These estimates reflect (1) full salaries with annual increases and employee turnover; (2) annual increases in ongoing operating expenses; and (3) termination of the contractual positions on September 30, 2028, consistent with the bill's termination date. As noted above, while it is assumed that program funding is provided in fiscal 2029 due to the mandated appropriation, the bill terminates at the end of the first quarter of that fiscal year. To the extent the contractual staff are retained through fiscal 2029 (despite the bill's termination date), fiscal 2029 administrative expenditures are higher.

This estimate does not include any health insurance costs that could be incurred for specified contractual employees under the State's implementation of the federal Patient Protection and Affordable Care Act.

Small Business Effect: The bill may have a meaningful impact on small businesses that sell and install doorbell cameras and security systems with doorbell cameras – or that provide training on the use of such cameras and systems – due to the funding provided under the bill for the purchase and installation of such cameras and systems.
