**Heating, Ventilation, Air-Conditioning, and Refrigeration Contractors - License  
Restoration**

---

This departmental bill extends the time period (from 90 days to four years) during which a licensee of the State Board of Heating, Ventilation, Air Conditioning, and Refrigeration (HVACR) Contractors may apply for a license restoration after expiration.

---

**Fiscal Summary**

**State Effect:** The State Board of HVACR Contractors can implement the bill's changes with existing budgeted resources. Revenues and expenditures are likely not materially affected.

**Local Effect:** None.

**Small Business Effect:** The Maryland Department of Labor (MD Labor) has determined that this bill has minimal or no impact on small business (attached). The Department of Legislative Services concurs with this assessment.

**Analysis**

**Bill Summary/Current Law:** If an application for a license restoration is made within 90 days of expiration (four years under the bill), the license may be restored on payment of *the required renewal or reinstatement* fee. If application for restoration is not made within the 90-day period (four years under the bill), the State Board of HVACR Contractors may require compliance with the process for initial applications as if the applicant had never been licensed. Current renewal fees (which are the same as fees for an original

license) range from \$12 for an apprentice license to \$94.50 for a master or limited license. Fees are paid to the State Occupational Mechanical Licensing Boards' Fund.

**Background:** MD Labor advises that it is necessary to extend the time within which an HVACR licensee may seek renewal or reinstatement of an expired license. Under current law, any request for reinstatement after 90 days of license expiration requires an individual to qualify for an original license, including passing a license examination. Certain licensees (*e.g.*, an individual recovering from an injury) may not realize within the 90-day period that their license has expired and may not have access to the electronic application platform. The bill is intended to mirror the reinstatement requirements for other mechanical licensing boards within MD Labor.
