House Bill 1524 Ways and Means (Wicomico County Delegation)

# Wicomico County Board of Education - Election of Members, Student Member, and Compensation

This bill adds a nonvoting student member to the Wicomico County Board of Education and requires that, beginning with the general election in 2026, the seven elected members of the board must each be elected from one of the seven councilmanic districts in the county. As a result, there are no at-large members of the board under the bill. The bill also authorizes the Wicomico County Council to set a salary greater than the current annual compensation amounts required for members (\$3,700) and board chair (\$4,000). Elected and student members are entitled to reimbursement for travel and other expenses, as provided in the county board's budget, upon submission of vouchers in accordance with rules and regulations adopted by the board. The student member is not entitled to any compensation or payment beyond reimbursement for expenses incurred in their capacity as a board member.

## **Fiscal Summary**

State Effect: None.

**Local Effect:** To the extent the Wicomico County Council chooses to set a salary greater than the current annual compensation amounts for board members, Wicomico County Board of Education salary expenditures increase. Any reimbursement for expense vouchers of elected and student members is assumed to be minimal and absorbable within existing resources of the board. The Wicomico County Board of Elections can make any needed adjustments to board member elections with existing resources.

**Small Business Effect:** None.

#### **Analysis**

**Bill Summary:** The student member of the board must be an eleventh or twelfth grade student in good standing and regularly enrolled in the Wicomico County Public School System (WCPS). Student members must serve for a term of one year beginning July 1 after the selection of the member. The student member is charged with advising the county board on the thoughts and feelings of students in WCPS. Unless invited to attend by an affirmative vote of a majority of the elected members of the board, the student member may not attend a closed session of the county board. The bill makes additional technical changes to distinguish between student and nonstudent (elected) members of the board.

**Current Law:** The Wicomico County Board of Education consists of seven nonpartisan members with one member elected from each of the five councilmanic districts in the county elected by the voters of each district and two at-large members elected by the voters of the entire county. Members are elected in gubernatorial election years and serve a term of four years until a successor is elected and qualifies.

The Wicomico County Board of Education is one of 20 elected school boards in the State and one of two boards without a student member (the other board being the Somerset County Board of Education). Of the 22 boards with student members, eight allow student members to vote on at least some matters before the board. The remainder are nonvoting student members. The **Appendix – Local Boards of Education Membership** shows the selection methods, terms of office, and membership of the 24 local boards of education.

Each member of the Wicomico County Board of Education must receive \$3,700 annually as compensation, except for the chair of the board who must receive \$4,000 annually.

**Additional Comments:** Although the bill requires that members be elected from each of seven councilmanic districts, there are presently only five councilmanic districts in Wicomico County. However, Wicomico County has proposed a new <u>seven-member councilmanic district map</u> pursuant to a consent decree agreed to by Wicomico County and the NAACP. Accordingly, this analysis assumes that a revised seven-district councilmanic map will be finalized and implemented prior to the 2026 general election.

#### **Additional Information**

# **Appendix – Local Boards of Education Membership**

The composition of the local boards of education varies with members serving three- to four-year terms. Twenty counties have elected school boards and four counties have combined appointed and elected school boards. Twenty-two boards have student members; however, only 8 boards allow student members to vote, which generally excludes authority to vote on matters relating to collective bargaining and personnel. Three counties with voting student members also preclude student members from voting on matters relating to operating and capital budgets. **Exhibit 1** shows the selection methods, terms of office, and membership of the 24 local school boards.
