**State Government - Interdepartmental Advisory Committee on Small, Minority,  
and Women Business Affairs - Repeal**

---

This departmental bill repeals the Interdepartmental Advisory Committee on Small, Minority, and Women Business Affairs.

---

**Fiscal Summary**

**State Effect:** None. The bill repeals a dormant committee. No effect on revenues.

**Local Effect:** None.

**Small Business Effect:** The Governor’s Office of Small, Minority, and Women Business Affairs (GOSBA) has determined that this bill has minimal or no impact on small business (attached). The Department of Legislative Services concurs with this assessment.

**Analysis**

**Current Law:** The Interdepartmental Advisory Committee on Small, Minority, and Women Business Affairs is composed of (1) the secretary of each principal department of the Executive Branch of government, or their designee; (2) the State Superintendent of Schools, or designee; (3) the Secretary of Higher Education, or designee; and (4) the Special Secretary for the Office of Small, Minority, and Women Business Affairs. The committee must (1) advise the Special Secretary for the Office of Small, Minority, and Women Business Affairs on proposals to implement and enhance the duties of GOSBA, including the promotion of employment of minority persons in the State, and the promotion

of the growth and participation of minority business enterprises (MBEs) in the State; (2) gather such information that the committee deems necessary to promote GOSBA's goals; (3) provide other assistance that may be required to further the purposes of GOSBA and support MBEs; and (4) meet at the call of the Special Secretary for the Office of Small, Minority, and Women Business Affairs.

**Background:** The functions of the Interdepartmental Advisory Committee on Small, Minority, and Women Business Affairs began in 1986, when the Interdepartmental Advisory Committee for Minority Affairs was established within the Governor's Office of Minority Affairs. In June 2017, the Office was renamed the Governor's Office of Small, Minority, and Women Business Affairs, and the Committee was renamed the Interdepartmental Advisory Committee on Small Minority, and Women Business Affairs. Since that time, GOSBA has not received any indication that the legislative body has convened. Due to the lack of activity, GOSBA proposes to repeal the committee. In its place, GOSBA plans to establish a new advisory committee to provide counsel to the Special Secretary on initiatives to enhance the office's responsibilities and promote the growth and participation of MBEs, veteran-owned small business enterprises, and small and minority-owned businesses in the State.
